A bill to be entitled

An act relating to license plates; amending s. 320.06, F.S.; requiring counties to issue license plates with either "Sunshine State" or the official state motto printed on the plate in lieu of the county name; providing conditions; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraph (a) of subsection (3) of section320.06, Florida Statutes, is amended to read:

320.06 Registration certificates, license plates, and
validation stickers generally.--

Registration license plates shall be of metal 14 (3) (a) 15 specially treated with a retroreflective material, as specified by the department. The registration license plate is designed to 16 17 increase nighttime visibility and legibility and shall be at least 6 inches wide and not less than 12 inches in length, 18 unless a plate with reduced dimensions is deemed necessary by 19 20 the department to accommodate motorcycles, mopeds, or similar 21 smaller vehicles. Validation stickers shall be treated with a retroreflective material, shall be of such size as specified by 22 the department, and shall adhere to the license plate. The 23 24 registration license plate shall be imprinted with a combination 25 of bold letters and numerals or numerals, not to exceed seven 26 digits, to identify the registration license plate number. The 27 license plate shall also be imprinted with the word "Florida" at the top and the name of the county in which it is sold at the 28

29 bottom, except that apportioned license plates shall have the 30 word "Apportioned" at the bottom and license plates issued for vehicles taxed under s. 320.08(3)(d), (4)(m) or (n), (5)(b) or 31 32 (c), or (14) shall have the word "Restricted" at the bottom. 33 License plates issued for vehicles taxed under s. 320.08(12) must be imprinted with the word "Florida" at the top and the 34 35 word "Dealer" at the bottom. Manufacturer license plates issued for vehicles taxed under s. 320.08(12) must be imprinted with 36 37 the word "Florida" at the top and the word "Manufacturer" at the 38 bottom. License plates issued for vehicles taxed under s. 39 320.08(5)(d) or (e) must be imprinted with the word "Wrecker" at the bottom. Any county may, upon majority vote of the county 40 41 commission, elect to have the county name removed from the 42 license plates sold in that county. The words "Sunshine State" shall be printed in lieu thereof. In those counties where the 43 county commission has not removed the county name from the 44 45 license plate, the tax collector shall may, in addition to 46 issuing license plates with the county name printed on the 47 license plate, also issue license plates with either the official state motto or the words "Sunshine State" printed on 48 the license plate subject to the approval of the department and 49 a legislative appropriation for the additional license plates. A 50 license plate issued for a vehicle taxed under s. 320.08(6) may 51 52 not be assigned a registration license number, or be issued with 53 any other distinctive character or designation, that 54 distinguishes the motor vehicle as a for-hire motor vehicle. 55 Section 2. This act shall take effect July 1, 2008.
