**SUMMARY ANALYSIS**

The bill requires each licensed child care facility, family day care home, or large family child care home to, annually during the months of August and September, provide parents of each child enrolled in the home or facility detailed information relating to the influenza virus in an effort to educate those parents regarding the importance of immunizing their children against influenza as recommended by the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention.

The bill is expected to have no fiscal impact on state or local governments.

## FULL ANALYSIS

### I. SUBSTANTIVE ANALYSIS

#### A. EFFECT OF PROPOSED CHANGES:

##### CURRENT SITUATION

##### Required Immunizations

Currently, the US Department of Health and Human Services, Centers for Disease Control and Prevention, recommends that all children who are from 6 months through 18 years of age receive the inactivated influenza vaccine. The vaccine is not approved for children younger than 6 months of age.<sup>1</sup>

One of the statutory duties of the Department of Health (DOH or department) is to administer and enforce laws and rules relating to sanitation, control of communicable diseases, illnesses and hazards to health among humans and from animals to humans, and the general health of the people of the state.<sup>2</sup> The department's communicable disease prevention and control program must include programs for the prevention and control of vaccine-preventable diseases, including programs to immunize school children as required by s. 1003.22(3)-(11).<sup>3</sup> Immunization requirements for children are established by rule.<sup>4</sup>

The Department of Children and Family Services, as authorized by statute and rule,<sup>5</sup> currently requires each child care facility, family day care home and large family child care home to provide proof of immunization for the children in care. Each child care facility is responsible for obtaining from the custodial parent or legal guardian of each child in care a current, complete, and properly executed DOH Florida Certification of Immunization form (DH 680), or Religious Exemption from Immunization form (DH 681). Specific immunization requirements are detailed in the most current edition of the Department of Health publication entitled "Immunization Guidelines: Florida Schools, Child Care Facilities and Family Day Care Homes" (DH 150-615, July 2008), and include:

- Diphtheria, tetanus, and pertussis vaccine
- Polio vaccine
- Measles vaccine

- Mumps vaccine
- Rubella vaccine
- Varicella vaccine (Effective July 1, 2001)
- Haemophilus influenzae type b (Hib) vaccine
- Pneumococcal Conjugate vaccine (Effective January 1, 2008 for children 2 to 24 months of age)

School-aged children attending public or non-public schools are not required to have student health examination and immunization records on file at the child care facility, as such records are on file at the school where the child is enrolled.

**The Bill** requires each licensed child care facility, family day care home, or large family child care home to, annually during the months of August and September, provide parents of each child enrolled in the home or facility detailed information relating to the influenza virus in an effort to educate those parents regarding the importance of immunizing their children against influenza as recommended by the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention.

On March 25, 2009, the Health Care Services Policy Committee adopted a strikeall amendment that requires each licensed child care facility, family day care home, or large family child care home to, annually during the months of August and September, provide parents of each child enrolled in the home or facility detailed information relating to the influenza virus in an effort to educate those parents regarding the importance of immunizing their children against influenza as recommended by the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention.

The bill was reported favorably as a CS and the analysis reflects the amendment.
