### **SUMMARY ANALYSIS**

The bill includes the following statutory revisions and associated fiscal impacts on state government. The bill transfers the Invasive Plant Control Trust Fund in the Department of Environmental Protection to the Fish and Wildlife Conservation Commission ratifying actions taken pursuant to chapter 2008-150, Laws of Florida. This transfer formally completes action taken in the 2008 Legislative Session to move the Bureau of Invasive Plant Management in DEP to FWCC. Transfers all property, records, personnel, and administrative authority by a Type II transfer of the Bureau of Invasive Plant Management in the Department of Environmental Regulation to the Fish and Wildlife Conservation Commission.

This bill conforms to the House of Representatives FY 2009-2010 General Appropriations Act in that this bureau is appropriated in the Fish and Wildlife Conservation Commission.

This bill will become effective upon becoming law.

### I. SUBSTANTIVE ANALYSIS

### A. EFFECT OF PROPOSED CHANGES:

# **Present Situation**

As a result of changes made in the 2008 Legislative Session transferring the Bureau of Invasive Management from the Department of Environmental Protection to the Fish and Wildlife Conservation Commission, the formal transfer of the Invasive Plant Control Trust Fund and all administrative transfers of personnel, records, appropriations, and property was not completed. To enact the legislative change, the Department of Environmental Protection and the Fish and Wildlife Conservation Commission entered into an interagency agreement providing for the administrative and operational matters to be conducted between the two entities. The two agencies have acted under this agreement during Fiscal Year 2008-2009 awaiting the formal transfer contained in this legislation.

The Bureau of Invasive Plant Management is responsible for directing, coordinating and funding two statewide programs controlling invasive upland plants on public conservation lands and invasive aquatic plants in public waterways. This bureau also regulates, through a permitting program, projects for the control of aquatic plants that do not meet the eligibility requirements for state funding. Florida's native plant and wildlife diversity is protected through the use of controls to manage invasive plants on public lands and waterways; through the dissemination of information and public education efforts; through contractual research; and through the surveillance of plant communities on public lands and waterways to prevent new, invading plant species from becoming well-established.
