### SUMMARY ANALYSIS

This joint resolution proposes an amendment to Article VII, section 3 of the Florida Constitution to provide an additional ad valorem tax exemption on homestead property for each person who is a member of the United States military or military reserves, the United States Coast Guard or its reserves, or the Florida National Guard, who receives a homestead exemption provided in Article VII, section 6 of the Florida Constitution, and who was deployed during the preceding calendar year on active duty outside the continental United States, Alaska, or Hawaii in support of military operations designated by the Legislature divided by the number of days in that year.

This additional exemption would be equal to a percentage of the taxable value of his or her homestead property. The applicable percentage would be calculated as the number of days during the preceding calendar year the person was deployed on active duty outside the continental United States, Alaska, or Hawaii in support of military operations designated by the Legislature divided by the number of days in that year.

The proposed amendment will be submitted to the electors at the general election in November 2010 or at an earlier special election if specifically authorized by law enacted by the Legislature for that purpose. If approved by 60 percent of the voters at the 2010 general election, the proposed amendment will take effect on January 1, 2011, and first apply to assessments in 2011.

The Department of State estimates that the cost of the proposed constitutional amendment is \$86,213. This cost is the result of placing the amendment on the ballot and publishing the notices as required by the Florida Constitution.

The Revenue Estimating Conference (REC) adopted an indeterminate negative fiscal impact beginning in FY 2011-12 because the proposed amendment would require voter approval. However, if the amendment had been in effect for FY 2009-10, the REC estimates the potential statewide negative fiscal impact would be approximately \$13 million, assuming current millage rates.

**The joint resolution must be approved by a three-fifths vote of the membership of each house of the Legislature.**

## FULL ANALYSIS

### I. SUBSTANTIVE ANALYSIS

#### A. EFFECT OF PROPOSED CHANGES:

##### Present Situation

##### General Overview of Ad Valorem Taxation

The ad valorem tax or "property tax" is an annual tax levied by counties, cities, school districts, and some special districts based on the value of real and tangible personal property as of January 1 of each year.<sup>1</sup> The "taxable value" of real and tangible personal property is the fair market value, or "just value," of the real and tangible personal property adjusted for any exclusions, differentials, or exemptions allowed by the constitution or the statutes.<sup>2</sup> Tax bills are mailed in November of each year based on the previous January 1 valuation and payment is due by the following March 31.

Property taxes are the largest single tax revenue source for local governments in Florida, with approximately \$31.0 billion levied in fiscal year 2007–08.

The Florida Constitution reserves ad valorem taxation to local governments and prohibits the state from levying ad valorem taxes on real and tangible personal property.<sup>3</sup> In addition, the Florida Constitution strictly limits the Legislature's authority to provide exemptions or adjustments to fair market value.<sup>4</sup> However, the Florida Constitution provides for property tax relief in the form of valuation differentials, assessment limitations, and exemptions.<sup>5</sup>

##### Property Tax Benefits Available to Veterans

Chapter 196, F.S., provides the following homestead exemptions that may apply to military service veterans:

- for certain permanently and totally disabled veterans and for surviving spouses of veterans;<sup>6</sup>
- for disabled veterans confined to wheelchairs;<sup>7</sup>
- for totally and permanently disabled persons;<sup>8</sup> and
- for certain disabled ex-service members or surviving spouses.<sup>9</sup>

In addition, current law provides the following discount that may apply to military service veterans:

- An ad valorem tax discount for veterans who are age 65 or older who are partially or totally permanently disabled. This discount applies if the disability was combat related, the veteran was a Florida resident at the time of entering the military service of the United States, and the veteran was honorably discharged upon separation from military service.<sup>10</sup>

No special tax relief is provided to military personnel deployed on active duty for military operations outside the United States.

Deployed Military Personnel<sup>11</sup>

The number of deployed military personnel is in constant flux. However, the following table shows the most recent data provided by the Florida Department of Military Affairs for the number of military personnel who claim Florida as their home of record, and are currently deployed overseas on active duty in support of Operation Iraqi Freedom and Operation Enduring Freedom:

## **Proposed Changes**

This joint resolution proposes an amendment to Article VII, section 3 of the Florida Constitution to provide an additional ad valorem tax exemption on homestead property for each person who is a member of the United States military or military reserves, the United States Coast Guard or its reserves, or the Florida National Guard, who receives a homestead exemption provided in Article VII, section 6 of the Florida Constitution, and who was deployed during the preceding calendar year on active duty outside the continental United States, Alaska, or Hawaii in support of military operations designated by the Legislature divided by the number of days in that year.

This additional exemption would be equal to a percentage of the taxable value of his or her homestead property. The applicable percentage would be calculated as the number of days during the preceding calendar year the person was deployed on active duty outside the continental United States, Alaska, or Hawaii in support of military operations designated by the Legislature divided by the number of days in that year.

Implementation of this exemption is subject to requirements enacted in general law regarding definitions, conditions, and procedures. However, the proposed amendment does not limit the Legislature's authority to enact general laws addressing issues other than definitions, conditions, and procedures.

The proposed amendment will be submitted to the electors at the general election in November 2010 or at an earlier special election if specifically authorized by law enacted by the Legislature for that purpose. If approved by 60 percent of the voters at the 2010 general election, the proposed amendment will take effect on January 1, 2011, and first apply to assessments in 2011.

### **B. SECTION DIRECTORY:**

## **II. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT**

### **A. FISCAL IMPACT ON STATE GOVERNMENT:**

#### **1. Revenues:**

The joint resolution will not have a direct effect on state government revenues.

#### **2. Expenditures:**

The state constitution requires publication of a proposed amendment or revision to the constitution in one newspaper of general circulation in each county in which a newspaper is published, once in the tenth week and once in the sixth week immediately preceding the week in which the election is held.<sup>12</sup>

Based on the 2008 election costs to advertise a proposed constitutional amendment, the Department of State, Division of Elections, estimates that the total non-recurring cost to advertise the proposed constitutional amendment is \$86,213. This cost is determined by multiplying the total number of words in the proposed amendment (approximately 937) by the per word cost of \$92.01.<sup>13</sup> The Department of State notes that there is no appropriation associated with the proposed joint resolution at this time.

**B. FISCAL IMPACT ON LOCAL GOVERNMENTS:**

**1. Revenues:**

The Revenue Estimating Conference (REC) adopted an indeterminate negative fiscal impact beginning in FY 2011-12 because the proposed amendment would require voter approval. However, if the amendment had been in effect for FY 2009-10, the REC estimates the potential statewide negative fiscal impact would be approximately \$13 million, assuming current millage rates.

**2. Expenditures:**

None.

**C. DIRECT ECONOMIC IMPACT ON PRIVATE SECTOR:**

Absent other factors, military personnel eligible for the homestead property tax credit proposed by this joint resolution would notice a reduction in property taxes beginning in 2011.

**D. FISCAL COMMENTS:**

The Department of Military Affairs and the Department of Revenue have indicated that the provisions of this joint resolution would have no operational impact on their respective agencies.

**III. COMMENTS**

**A. CONSTITUTIONAL ISSUES:**

**1. Applicability of Municipality/County Mandates Provision:**

The mandates provisions of Article VII, section 18 of the Florida Constitution do not apply to House Joint Resolutions.

**2. Other:**

Article XI, section 1 of the Florida Constitution authorizes the Legislature to propose amendments to the State Constitution by joint resolution approved by three-fifths of the membership of each house. The amendment must be placed before the electorate at the next general election held after the proposal has been filed with the Secretary of State's office or at a special election held for that purpose.

Article XI, section 5(e) of the Florida Constitution requires 60 percent voter approval for a constitutional amendment to pass.

**B. RULE-MAKING AUTHORITY:**

The joint resolution would not require any agency to adopt administrative rules. However, it may be necessary for the Legislature to authorize rulemaking by the Department of Revenue in future implementing legislation.

**C. DRAFTING ISSUES OR OTHER COMMENTS:**

None.

#### **IV. AMENDMENTS/COUNCIL OR COMMITTEE SUBSTITUTE CHANGES**

On April 7, 2009, the Finance & Tax Council adopted a strike-all amendment. The original bill provided for a credit against future ad valorem taxes. The amendment provided for an additional exemption instead of a credit. The amendment also provided an implementation schedule. The schedule changed the effective date of the proposed amendment from January 4, 2011 to January 1, 2011 so the proposed amendment would apply to property tax assessments for 2011.
