SUMMARY ANALYSIS

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does the statute require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings.

CS/HB 847 designates the following honorary roads:

- That portion of State Road 9-A in Duval County on the east side of Jacksonville between Interstate 95 south of Jacksonville and Interstate 95 north of Jacksonville is designated as "Ronald W. Reagan Memorial Highway."
- That portion of State Road 60 beginning directly west of Interstate 95 interchange in Indian River County and ending at the Florida Turnpike interchange in Osceola County is designated as "Stan Mayfield Memorial Highway."
- That portion of U.S. 90 between Avalon Boulevard and Pace Patriot Boulevard in Pace, Florida is designated as "Army Sergeant Daniel L. McCall Memorial Highway."
- That portion of Sunset Harbor Road between S.E. 105th Avenue and S.E. 115th Avenue in Marion County is designated as "Samuel B. Love Memorial Highway."
- That portion of State Road 285, north of College Boulevard in Okaloosa and Walton Counties is designated as "Doolittle Raiders Highway."
- That portion of A1A from Shave Bridge to Line Street in Nassau County is designated as "Verna Bell Memorial Road."
- That portion of SR 79 from U.S. 98 in Panama City Beach, Bay County, Florida, to the B.V. Buchanan Bridge in West Bay, Bay County, Florida, is designated as the "K. Earl Durden Highway."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers designating the honorary roads. The markers will cost an estimated \$400 each. Assuming that two markers will be erected for each designation, the estimated fiscal impact to FDOT will be \$5,600. This includes maintenance and installation costs.

CS/HB 847 does not create any constitutional or other legal issues. It takes effect July 1, 2009.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Current Situation

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does the statute require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings.

The statute requires the Florida Department of Transportation (FDOT) to place a marker at each terminus or intersection of an identified road or bridge, and to erect other markers it deems appropriate for the transportation facility. The statute also provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties, a resolution must be passed by each affected local government.

Effect of CS/HB 847

CS/HB 847 designates the following honorary roads:

That portion of Highway 9-A in Duval County between Interstate 95 north of the St. Johns County line and Interstate 95 south of the Jacksonville International Airport exit is designated as "Ronald W. Reagan Memorial Highway."

That portion of State Road 60 beginning directly west of Interstate 95 interchange in Indian River County and ending at the Florida Turnpike interchange in Osceola County is designated as "Stan Mayfield Memorial Highway."

That portion of U.S. 90 between Avalon Boulevard and Pace Patriot Boulevard in Pace, Florida is designated as "Army Sergeant Daniel L. McCall Memorial Highway."

That portion of Sunset Harbor Road between S.E. 105th Avenue and S.E. 115th Avenue in Marion County is designated as "Samuel B. Love Memorial Highway."

That portion of State Road 285, north of College Boulevard in Okaloosa and Walton Counties is designated as "Doolittle Raiders Highway."

That portion of A1A from Shave Bridge to Line Street in Nassau County is designated as "Verna Bell Memorial Road."

That portion of SR 79 from U.S. 98 in Panama City Beach, Bay County, Florida, to the B.V. Buchanan Bridge in West Bay, Bay County, Florida, is designated as the "K. Earl Durden Highway."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers designating the honorary roads.
