Subsection (4) is added to section 202.29, 15 Florida Statutes, to read: 16 202.29 Bad debts.--17 (4) (a) A dealer may report the credit for bad debt allowed under this section by netting such credit against the tax due to 18 19 the state pursuant to s. 202.12 or to a local jurisdiction 20 pursuant to s. 202.19, but such netting may not reduce the 21 amount due to the state or to any local jurisdiction below zero. 22 (b) For purposes of determining the amount of bad debt 23 that is attributable to the state or to a local jurisdiction, a 24 dealer may employ a proportionate allocation method based on current gross taxes due or another reasonable allocation method 25 26 approved by the department. 27 Section 2. This act shall operate retroactively to July 1, 28 2000; however, the retroactive operation of this act is remedial
