 2           An act relating to road designations; designating Ray  
 3           Charles Memorial Parkway in Madison County; designating  
 4           Deputy Victor J. "Skip" McDonald Memorial Highway and  
 5           Trooper Charles Eugene Campbell Memorial Highway in Taylor  
 6           County; designating Frank Pasquarella Way and Bob  
 7           Arbetter's Way in Miami-Dade County; directing the  
 8           Department of Transportation to erect suitable markers;  
 9           providing an effective date.

11 Be It Enacted by the Legislature of the State of Florida:

13           Section 1. Ray Charles Memorial Parkway designated;  
 14 Department of Transportation to erect suitable markers.-

15           (1) That portion of U.S. Highway 90 within the boundaries  
 16 of the Town of Greenville in Madison County is designated as  
 17 "Ray Charles Memorial Parkway."

18           (2) The Department of Transportation is directed to erect  
 19 suitable markers designating Ray Charles Memorial Parkway as  
 20 described in subsection (1).

21           Section 2. Deputy Victor J. "Skip" McDonald Memorial  
 22 Highway designated; Department of Transportation to erect  
 23 suitable markers.-

24           (1) That portion of State Road 51 between U.S. Highway 19  
 25 at Tennille and the Dixie County line in Taylor County is  
 26 designated as "Deputy Victor J. 'Skip' McDonald Memorial  
 27 Highway."

28           (2) The Department of Transportation is directed to erect  
 29 suitable markers designating Deputy Victor J. "Skip" McDonald  
 30 Memorial Highway as described in subsection (1).

31           Section 3. Trooper Charles Eugene Campbell Memorial  
 32 Highway designated; Department of Transportation to erect  
 33 suitable markers.-

34           (1) That portion of U.S. Highway 19 between Slaughter Road  
 35 and Harrison Blue Road in Taylor County is designated as  
 36 "Trooper Charles Eugene Campbell Memorial Highway."

37           (2) The Department of Transportation is directed to erect  
 38 suitable markers designating Trooper Charles Eugene Campbell  
 39 Memorial Highway as described in subsection (1).

40           Section 4. Frank Pasquarella Way designated; Department of  
 41 Transportation to erect suitable markers.-

42           (1) That portion of Bird Road, S.W. 40th Street, between  
 43 S.W. 89th Avenue and S.W. 92nd Avenue in Miami-Dade County is  
 44 designated as "Frank Pasquarella Way."

45           (2) The Department of Transportation is directed to erect  
 46 suitable markers designating Frank Pasquarella Way as described  
 47 in subsection (1).

48           Section 5. Bob Arbetter's Way designated; Department of  
 49 Transportation to erect suitable markers.-

50           (1) That portion of Bird Road, S.W. 40th Street, between  
 51 S.W. 87th Avenue and S.W. 89th Avenue in Miami-Dade County is  
 52 designated as "Bob Arbetter's Way."

53           (2) The Department of Transportation is directed to erect  
 54 suitable markers designating Bob Arbetter's Way as described in  
 55 subsection (1).
