The Legislature finds that the seal of the National Association of Fundraising Ticket Manufacturers, when affixed to any instant bingo or gaming product, ensures that the product meets or exceeds any state standard and the standards established by the North American Gaming Regulators Association. <u>2. Each manufacturer of instant bingo tickets distributed</u> in this state shall affix to each deal the tamper-resistant seal of the National Association of Fundraising Ticket Manufacturers,

14	that certifies that the product complies with state law.
15	a. Each deal, including the flare, must be sealed at the

18	from outside the deal and must include a warning message to the
