19	from outside the deal and must include a warning message to the		
20	purchaser that the deal may have been tampered with if the seal		
21	is not intact.		
22	(b) Evidence of a seal is prima facie evidence that the		
23	product complies with state law. Absence of the seal is prima		
24	facie evidence that the product does not comply with state law.		
25	(3) A manufacturer that is not a member of the National		
26	Association of Fundraising Ticket Manufacturers shall affix to		
27	any deal it manufactures a seal from a recognized independent		
28	testing laboratory certifying that the product complies with		
29	state law. The seal must be issued to the manufacturer by a
