### **Background**

In 1969, the Legislature established the nine-member State Board of Social Services (Board), <sup>1</sup> one of a number of predecessors to the Department of Health and Human Services (HRS) and now the Department of Children and Families (DCF). The law contained a sentence that prohibited a federal, state, county or municipal officer from serving as a member of the Board. The exact reason those public officers were not allowed to serve is unknown. However, through the agency's many legislative reorganizations, the prohibition has remained in statute.
