Section 3. Paragraph (o) is added to subsection (15) of section 320.02, Florida Statutes, to read:

320.02 Registration required; application for registration; forms.-

(o) Notwithstanding s. 26 of chapter 2010-223, Laws of Florida, the application form for motor vehicle registration and renewal registration must include a provision permitting a voluntary contribution of \$1 or more per applicant, to be



distributed to the Auto Club South Traffic Safety Foundation, a nonprofit organization. Funds received by the foundation shall be used to improve traffic safety culture, including the use of child restraint devices, in communities through effective outreach, education, and activities that will save lives, reduce injuries, and prevent crashes. The foundation must comply with s. 320.023.

Section 4. Paragraph (o) is added to subsection (7) of section 322.08, Florida Statutes, to read:

322.08 Application for license; requirements for license and identification card forms.-

- (7) The application form for an original, renewal, or replacement driver's license or identification card shall include language permitting the following:
- (o) Notwithstanding s. 26 of chapter 2010-223, Laws of Florida, a voluntary contribution of \$1 or more per applicant to the Auto Club South Traffic Safety Foundation, a nonprofit organization. Funds received by the foundation shall be used to improve traffic safety culture, including the use of child restraint devices, in communities through effective outreach, education, and activities that will save lives, reduce injuries, and prevent crashes.
