- 513.01 Definitions.—As used in this chapter, the term:

(4) Local governmental actions, ordinances, and resolutions must be consistent with the uniform standards established pursuant to this chapter and as implemented by rules of the department. This chapter does not limit the authority of a local government to adopt and enforce land use, building, firesafety, and other regulations.

(5) However, nothing in this chapter qualifies a mobile home park, a lodging park, a recreational vehicle park, or a recreational camp for a liquor license issued under s. 561.20(2)(a)1. If any person is illegally on the premises of any recreational vehicle park, the operator of such park may call upon any law enforcement officer of this state for assistance. It is the duty of such law enforcement officer, upon the request of such operator, to place under arrest and take into custody for violation of this section any guest who violates subsection (1) or subsection (2) in the presence of the officer. If a warrant has been issued by the proper judicial officer for the arrest of any violator of subsection (1) or subsection (2), the officer shall serve the warrant, arrest the person, and take the person into custody. Upon arrest, with or without warrant, the guest is deemed to have given up any right to occupancy or to have abandoned the guest's right to occupancy of the premises of the recreational vehicle park; and the operator of the park shall employ all reasonable and proper means to care for any personal property left on the premises by such quest and shall refund any unused portion of moneys paid by such quest for the occupancy of such premises. The operator is not liable for damages to personal property left on the premises by a guest who violates subsection (1) or subsection (2) and is arrested by a law enforcement officer.
