1003.455, Florida Statutes, are amended to read:

1003.455 Physical education; assessment.

- (3) Each district school board shall provide 150 minutes of physical education each week for students in kindergarten through grade 5 and for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 30 consecutive minutes per day.
- (4) Beginning with the 2009-2010 school year, The equivalent of one class period per day of physical education for one semester of each year is required for students enrolled in grades 6 through 8. ## Amendment No. 3

An act relating to physical education in the public schools; amending s. 1003.455, F.S.; limiting the parental waiver of physical education requirements for students in kindergarten through grade 8 to one semester per school year; revising requirements for the parental waivers; deleting an obsolete provision; reorganizing and conforming provisions; providing an effective date.

WHEREAS, every year, an estimated 300,000 people in the United States die because they are overweight or obese, and WHEREAS, since 1970, the number of overweight children in
