## Amendment (with title amendment)

Remove everything after the enacting clause and insert: Section 1. Subsections (3), (4), and (5) of section 1003.455, Florida Statutes, are amended to read:

- 1003.455 Physical education; assessment.
- (3) Each district school board shall provide 150 minutes of physical education each week for students in kindergarten through grade 5 and for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 30 consecutive minutes per day.
- (4) Each district school board shall provide 225 minutes of physical education each week for students in grade 6 who are enrolled in a school that contains one or more elementary grades so that on any day during which physical education instruction is conducted there are at least 45 consecutive minutes per day.

- equivalent of one class period per day of physical education for one semester of each year is required for students enrolled in grades 6 through 8. Students enrolled in such instruction shall be reported through the periodic student membership surveys, and records of such enrollment shall be audited pursuant to s. 1010.305. Such instruction may be provided by any instructional personnel as defined in s. 1012.01(2), regardless of certification, who are designated by the school principal.
- (6) (4) The <u>requirements</u> requirement in <u>subsections (3)-(5)</u> subsection (3) shall be waived for <u>one semester per school year</u> for a student who meets one of the following criteria:
- (a) The student is enrolled or required to enroll in a remedial course.
- (b) The student's parent <u>requests</u> in writing to the school that:
- 1. The parent requests that the student enroll in another course, which may include, but is not limited to, from among those courses offered as options by the school district; or
- (c) 2. The student's parent certifies in writing and provides documentation to the school that the student is participating in physical activities outside the school day which are equal to or in excess of the mandated requirement.
- (7)(5) Each school district shall notify the student's parent of the options available under <u>subsection</u> (6) <del>subsection</del> (4) before scheduling the student to participate in physical education.

An act relating to physical education in the public schools; amending s. 1003.455, F.S.; revising the amount of physical education that district school boards must provide each week for students in grade 6 who are enrolled in schools that contain one or more elementary grades; limiting the parental waiver of physical education requirements for students in kindergarten through grade 8 to one semester per school year; revising requirements for the parental waivers; deleting an obsolete provision; reorganizing and conforming provisions; providing an effective date.
