13	Be It Enacted by the Legislature of the State of Florida:

15	Section 1. Paragraph (a) of subsection (9) of section
16	24.105, Florida Statutes, is amended to read:
17	24.105 Powers and duties of departmentThe department
18	shall:
19	(9) Adopt rules governing the establishment and operation
20	of the state lottery, including:
21	(a) The type of lottery games to be conducted, except
22	that:
23	1. No name of an elected official shall appear on the
24	ticket or play slip of any lottery game or on any prize or on
25	any instrument used for the payment of prizes, unless such prize
26	is in the form of a state warrant.
27	2. No coins or currency shall be dispensed from any
28	electronic computer terminal or device used in any lottery game.

3. Other than as <u>specifically</u> provided in <u>s. 24.112</u>
30 subparagraph 4., no terminal or device may be used for any
31 lottery game which may be operated solely by the player without
32 the assistance of the retailer.

33 The only player-activated machine which may be utilized 4 34 is a machine which dispenses instant lottery game tickets 35 following the insertion of a coin or currency by a ticket 36 purchaser. To be authorized a machine must: be under the 37 supervision and within the direct line of sight of the lottery 38 retailer to ensure that the machine is monitored and only 39 operated by persons at least 18 years of age; be capable of being electronically deactivated by the retailer to prohibit use 40 41 by persons less than 18 years of age through the use of a 42 lockout device that maintains the machine's deactivation for a 43 period of no less than 5 minutes; and be designed to prevent its 44 use or conversion for use in any manner other than the dispensing of instant lottery tickets. Authorized machines may 45 dispense change to players purchasing tickets but may not be 46 47 utilized for paying the holders of winning tickets of any kind. At least one clerk must be on duty at the lottery retailer while 48 49 the machine is in operation. However, at least two clerks must 50 be on duty at any lottery location which has violated s. 51 24.1055. 52 Section 2. Paragraph (h) of subsection (2) of section 24.111, Florida Statutes, is amended to read: 53 54 24.111 Vendors; disclosure and contract requirements.-55 (2)The department shall investigate the financial 56 responsibility, security, and integrity of each vendor with Page 2 of 5

57 which it intends to negotiate a contract for major procurement. 58 Such investigation may include an investigation of the financial 59 responsibility, security, and integrity of any or all persons 60 whose names and addresses are required to be disclosed pursuant 61 to paragraph (a). Any person who submits a bid, proposal, or offer as part of a major procurement must, at the time of 62 63 submitting such bid, proposal, or offer, provide the following: 64 (h) The department shall lease all instant ticket vending 65 machines that dispense online lottery tickets, instant lottery tickets, or both online and instant lottery tickets. 66 67 The department shall not contract with any vendor who fails to 68 69 make the disclosures required by this subsection, and any 70 contract with a vendor who has failed to make the required disclosures shall be unenforceable. Any contract with any vendor 71 72 who does not comply with such requirements for periodically 73 updating such disclosures during the tenure of such contract as 74 may be specified in such contract may be terminated by the 75 department. This subsection shall be construed broadly and 76 liberally to achieve the ends of full disclosure of all 77 information necessary to allow for a full and complete 78 evaluation by the department of the competence, integrity, 79 background, and character of vendors for major procurements. 80 Section 3. Subsection (15) is added to section 24.112, 81 Florida Statutes, to read: 82 24.112 Retailers of lottery tickets; authorization of 83 vending machines to dispense lottery tickets.-

84	(15) A vending machine may be used to dispense online
85	lottery tickets, instant lottery tickets, or both online and
86	instant lottery tickets.
87	(a) The vending machine must:
88	1. Dispense a lottery ticket after a purchaser inserts a
89	coin or currency in the machine.
90	2. Be capable of being electronically deactivated for a
91	period of 5 minutes or more.
92	3. Be designed to prevent its use for any purpose other
93	than dispensing a lottery ticket.
94	(b) In order to be authorized to use a vending machine to
95	dispense lottery tickets, a retailer must:
96	1. Locate the vending machine in the retailer's direct
97	line of sight to ensure that purchases are only made by persons
98	at least 18 years of age.
99	2. Ensure that at least one employee is on duty when the
100	vending machine is available for use. However, if the retailer
101	has previously violated s. 24.1055, at least two employees must
102	be on duty when the vending machine is available for use.
103	(c) A vending machine that dispenses a lottery ticket may
104	dispense change to a purchaser but may not be used to redeem any
105	type of winning lottery ticket.
106	(d) The vending machine, or any machine or device linked
107	to the vending machine, may not include or make use of video
108	reels or mechanical reels or other video depictions of slot
109	machine or casino game themes or titles for game play. This does
110	not preclude the use of casino game themes or titles on such
111	tickets or signage or advertising displays on the machines.
