

1 A bill to be entitled
 2 An act relating to the West Palm Beach Water Catchment
 3 Area, Palm Beach County; amending chapter 67-2169,
 4 Laws of Florida, as amended; revising boundaries;
 5 providing an effective date.

 7 Be It Enacted by the Legislature of the State of Florida:

 9 Section 1. Section 1 of chapter 67-2169, Laws of Florida,
 10 as amended by chapter 2006-359, Laws of Florida, is amended to
 11 read:

12 Section 1. West Palm Beach Water Catchment area
 13 described.—The following described lands in Palm Beach County,
 14 Florida, owned by the City of West Palm Beach, Florida, form the
 15 West Palm Beach water catchment area, to wit:

 17 PARCEL ONE.

18
 19 The South fifty feet (50') ~~four hundred fifty feet~~
 20 ~~(450')~~ of the Southwest quarter (SW 1/4) of Section
 21 one (1) in Township forty-three South (43 S), Range
 22 forty-two East (42 E), except right-of-way of Military
 23 Trail and Haverhill Road.

24
 25 PARCEL TWO.

27 The South four hundred fifty feet (450') of the
28 Southeast quarter (SE 1/4) and the entire Southwest
29 quarter (SW 1/4) of Section two (2) of Township forty-
30 three South (43 S), Range forty-two East (42 E),
31 except right-of-way for Haverhill Road subject,
32 however, to that certain easement from Model Land
33 Company to Florida Power and Light Company dated
34 September 16, 1931, to construct and operate power
35 lines on the East side of said property.

36
37 Said PARCEL TWO being also subject to 160 ft. width
38 electric power and communication line easement as
39 granted by West Palm Beach Water Company unto Florida
40 Power and Light company by right-of-way agreement
41 dated June 23, 1953, recorded in Deed Book 1023, page
42 680, Palm Beach County Public Records. (Less Right-of-
43 Way of Haverhill Road.)

47 The South half (S 1/2) of Section three (3), Township
48 forty-three South (43 S), Range forty-two East (42 E).

50 Less and except Jog Road extension described as

54 | three South (43 S), Range forty-two East (42 E), Palm
55 | Beach County, Florida, more particularly described as

58 | Section three (3), N 88°43'44" W for 302.06 feet to
59 | the West right-of-way line of Florida's Turnpike,
60 | recorded in Circuit Court Minutes Book 68, page 204,
61 | of the public records of Palm Beach County, Florida;
62 | thence along said right-of-way line, N 01°54'17" E for
63 | 2,188.38 feet to the point of curvature of a curve
64 | concave to the east, having a radius of 43,121.85

66 | way line to the right, through a central angle of
67 | 0°39'37" for 496.98 feet to the north line of the
68 | South half (S 1/2) of said Section three (3); thence

 88 The North four hundred fifty feet (450') of Northwest
 89 quarter (NW 1/4) of Section twelve (12), Township
 90 forty-three South (43 S), Range forty-two East (42 E),
 91 as conveyed to West Palm Beach Water Company by Model
 92 Land Company's two deeds of July 12, 1944, recorded in
 93 Deed Book 694, page 317, and Deed Book 694, page 319,
 94 subject to right-of-way of Military Trail. (Less
 95 Right-of-Way of Haverhill Road.)

 97 Subject also to easement from Model Land Company to
 98 Florida Power and Light Company dated September 16,
 99 1931, to construct and operate power lines on west
 100 side of said North half (N 1/2) of Northwest quarter
 101 (NW 1/4) of said Section twelve (12). 12;

105 The North half (N 1/2) One-Half of the North half (N
106 1/2) One-Half of the Northwest quarter (NW 1/4) One-
107 Quarter of the Northeast quarter (NE 1/4) One-Quarter,
108 Section ten (10), Township forty-three South (43 S),
109 Range forty-two East (42 E).

113 All of Section seventeen (17) lying South of Seaboard
114 Air Line Railway, all of Sections eighteen (18),
115 nineteen (19) and twenty (20), all of Section twenty-
116 one (21) south of Seaboard Air Line Railway; all of
117 Sections twenty-eight (28), twenty-nine (29), thirty
118 (30), thirty-one (31), thirty-two (32) and thirty-
119 three (33), all being in Township forty-two (42) South
120 (42 S), Range forty-two East (42 E).

122 PARCEL EIGHT.

124 That part of South one-half (S 1/2) of Section sixteen
125 (16), Township forty-two (T 42) South (42 S), Range
126 forty-two (R 42) East (42 E), lying south and west of
127 right-of-way of Florida Western and Northern Railroad
128 Company as described in Deed Book 225, Page 160, of
129 Palm Beach County public records, now owned by
130 Seaboard Air Line Railroad Company.

 132 Said PARCELS SEVEN and EIGHT being subject to easement
 133 of Palm Beach County, Florida, for public road known
 134 as Lake Park Road across said sections 16-17-18-19-20-
 135 21.

 137 Said Sections 17-18 in said PARCEL SEVEN being also
 138 subject to agreement between West Palm Beach Water
 139 Company and Palm Beach County by Deed of February 26,
 140 1951, recorded in Deed Book 936, page 151, permitting
 141 removal by said County of shell not exceeding 15 ft.
 142 in depth by the present level of water from said land.

 144 Part of said Section thirty-two (32) 32 of Township 42
 145 South (42 S), Range 42 East (42 E) in said PARCEL
 146 SEVEN being subject to an estate, for its his natural
 147 life, in Ike Lee, with remainder to Model Land
 148 Company, its successors and assigns, as described in
 149 Indenture of August 21, 1942, between J.C. Bills, Jr.,
 150 et als, parties of the first part, Ike Lee, party of
 151 the second part, and Model Land Company, party of the
 152 third part, recorded Deed Book 656, page 102, Public

 236 | more or less to the southwest corner of Section 31, T
 237 | 42 S, R 41 E; thence proceed S 1° 41' W a distance of
 238 | 250.11' more or less, to a point; thence proceed S 88°
 239 | 37' W a distance of 5,281.62' more or less to the
 240 | point of beginning; the above described lands lying in
 241 | Section 36, T 42 S, R 40 E and containing 30.3 acres,
 242 | more or less.
