54 | 1001.7065 Preeminent state research universities program.—

55 | (4) PREEMINENT STATE RESEARCH UNIVERSITY INSTITUTE FOR
56 | ONLINE LEARNING.—A state research university that, as of July 1,
57 | 2013, meets all 12 of the academic and research excellence
58 | standards identified in subsection (2), as verified by the Board
59 | of Governors, shall establish an institute for online learning.
60 | The institute shall establish a robust offering of high-quality,
61 | fully online baccalaureate degree programs at an affordable cost
62 | in accordance with this subsection.

63 | (k) The university shall establish a tuition structure for
64 | its online institute in accordance with this paragraph,
65 | notwithstanding any other provision of law.

66 | 1. For students classified as residents for tuition
67 | purposes, tuition for an online baccalaureate degree program
68 | shall be set at no more than 75 percent of the tuition rate as
69 | specified in the General Appropriations Act pursuant to s.
70 | 1009.24(4) and 75 percent of the tuition differential pursuant
71 | to s. 1009.24(16). No distance learning fee, fee for campus
72 | facilities, or fee for on-campus services may be assessed,
73 | except that online students shall pay the university's
74 | technology fee, financial aid fee, and Capital Improvement Trust
75 | Fund fee. The revenues generated from the Capital Improvement
76 | Trust Fund fee shall be dedicated to the university's institute
77 | for online learning.

80 | the business plan.

81 | 3. Tuition for an online degree program shall include all
82 | costs associated with instruction, materials, and enrollment,
83 | excluding costs associated with the provision of textbooks and
84 | instructional materials pursuant to s. 1004.085 and physical
85 | laboratory supplies.

86 | 4. Subject to the limitations in subparagraph 1., tuition
87 | may be differentiated by degree program as appropriate to the
88 | instructional and other costs of the program in accordance with
89 | the business plan. Pricing must incorporate innovative
90 | approaches that incentivize persistence and completion,
91 | including, but not limited to, a fee for assessment, a bundled
92 | or all-inclusive rate, and sliding scale features.

93 | 5. The university must accept advance payment contracts
94 | and student financial aid.

95 | 6. Fifty percent of the net revenues generated from the
96 | online institute of the university shall be used to enhance and
97 | enrich the online institute offerings, and 50 percent of the net
98 | revenues generated from the online institute shall be used to
99 | enhance and enrich the university's campus state-of-the-art
100 | research programs and facilities.

108 | Section 2. Section 1004.084, Florida Statutes, is created
 109 | to read:

110 | 1004.084 College affordability.—

111 | (1) The Board of Governors and the State Board of
 112 | Education shall annually identify strategies to promote college
 113 | affordability for all Floridians by evaluating, at a minimum,
 114 | the impact of:

115 | (a) Tuition and fees on undergraduate, graduate, and
 116 | professional students at public colleges and universities and
 117 | graduate assistants employed by public universities.

118 | (b) Federal, state, and institutional financial aid
 119 | policies on the actual cost of attendance for students and their
 120 | families.

121 | (c) The costs of textbooks and instructional materials.

122 | (2) By December 31 of each year, beginning in 2016, the
 123 | Board of Governors and the State Board of Education shall submit
 124 | a report on their respective college affordability initiatives
 125 | to the Governor, the President of the Senate, and the Speaker of
 126 | the House of Representatives.

 132 materials" means educational materials for use within a course
 133 which may be available in printed or digital format.

134 (2)~~(1)~~ An ~~No~~ employee of a Florida College System
 135 institution or state university may not demand or receive any
 136 payment, loan, subscription, advance, deposit of money, service,
 137 or anything of value, present or promised, in exchange for
 138 requiring students to purchase a specific textbook or
 139 instructional material for coursework or instruction.

140 (3)~~(2)~~ An employee may receive:

141 (a) Sample copies, instructor copies, or instructional
 142 materials. These materials may not be sold for any type of
 143 compensation if they are specifically marked as free samples not
 144 for resale.

145 (b) Royalties or other compensation from sales of
 146 textbooks or instructional materials that include the
 147 instructor's own writing or work.

148 (c) Honoraria for academic peer review of course
 149 materials.

150 (d) Fees associated with activities such as reviewing,
 151 critiquing, or preparing support materials for textbooks or
 152 instructional materials pursuant to guidelines adopted by the
 153 State Board of Education or the Board of Governors.

154 (e) Training in the use of course materials and learning
 155 technologies.

156 (4) Each Florida College System institution and state

157 | university board of trustees shall, each semester, examine the
158 | cost of textbooks and instructional materials by course and
159 | course section for all general education courses offered at the
160 | institution to identify any variance in the cost of textbooks
161 | and instructional materials among different sections of the same
162 | course and the percentage of textbooks and instructional
163 | materials that remain in use for more than one term. Courses
164 | that have a wide variance in costs among sections or that have
165 | frequent changes in textbook and instructional materials
166 | selections shall be identified and a list of such courses sent
167 | to the appropriate academic department chair for review. This
168 | subsection is repealed July 1, 2018, unless reviewed and saved
169 | from repeal through reenactment by the Legislature.

170 | (5) Each Florida College System institution and state

175 | include bulk pricing arrangements that enable students to
176 | purchase course materials or texts that are delivered digitally;
177 | delivered through other technologies that are, or the licenses
178 | of which are, required for use within a course; or delivered in
179 | a print format. Innovative pricing techniques and payment
180 | options must include an opt-in provision for students and may be
181 | approved only if there is documented evidence that the options
182 | reduce the cost of textbooks and instructional materials for

186 prominently in the course registration system and on its website
187 ~~on their websites~~, as early as is feasible, but at least 45 not

189 each term, a hyperlink to lists ~~list~~ of each ~~textbook~~ required
190 and recommended textbooks and instructional materials for at
191 least 95 percent of all courses and each course sections offered
192 at the institution during the upcoming term. The lists ~~posted~~
193 ~~list~~ must include the International Standard Book Number (ISBN)
194 for each required and recommended textbook and instructional
195 material or other identifying information, which must include,

214 guidelines shall address ~~provide for the following:~~

215 (a) The establishment of deadlines for an instructor or
216 department to notify the bookstore of required and recommended
217 textbooks and instructional materials so that the bookstore may
218 verify availability, source lower cost options when practicable,
219 explore alternatives with faculty when academically appropriate,
220 and maximize the availability of used textbooks and
221 instructional materials ~~That textbook adoptions are made with~~
222 ~~sufficient lead time to bookstores so as to confirm availability~~

268 selling, and sharing textbooks and instructional materials.

269 6. The length of time that textbooks and instructional
270 materials remain in use.

271 7. An evaluation of cost savings for textbooks and
272 instructional materials which a student may realize if
273 individual students are able to exercise opt-in provisions for
274 the purchase of the materials.

275 (8) The board of trustees of each Florida College System
276 institution and state university shall report, by September 30
277 of each year, beginning in 2016, to the Chancellor of the
278 Florida College System or the Chancellor of the State University
279 System, as applicable, the textbook and instructional materials
280 selection process for general education courses with a wide cost
281 variance identified pursuant to subsection (4) and high-
282 enrollment courses; specific initiatives of the institution
283 designed to reduce the costs of textbooks and instructional
284 materials; policies implemented in accordance with subsection
285 (6); the number of courses and course sections that were not
286 able to meet the textbook and instructional materials posting

288 information determined by the chancellors. By November 1 of each
289 year, beginning in 2016, each chancellor shall provide a summary
290 of the information provided by institutions to the State Board
291 of Education and the Board of Governors, as applicable.

292 Section 4. Subsection (20) is added to section 1009.23,
293 Florida Statutes, to read:

294 1009.23 Florida College System institution student fees.—

295 (20) Each Florida College System institution shall
296 publicly notice and notify all enrolled students of any proposal
297 to increase tuition or fees at least 28 days before its
298 consideration at a board of trustees meeting. The notice must:

299 (a) Include the date and time of the meeting at which the
300 proposal will be considered.

301 (b) Specifically outline the details of existing tuition
302 and fees, the rationale for the proposed increase, and how the
303 funds from the proposed increase will be used.

322 or fees at least 28 days before its consideration at a board of
323 trustees meeting. The notice must:
