Senate Amendment (with title amendment)

Section 1. Section 458.352, Florida Statutes, is created to
read:

458.352 Hair restoration or transplant.-

(1) As used in this section, the term "hair restoration or
transplant" means a surgical procedure that removes hair
follicles after they have been cored by a hollow punch or

27 (1) As used in this section, the term "hair restoration or
28 transplant" means a surgical procedure that removes hair
29 follicles after they have been cored by a hollow punch or
30 robotic instrument, dissects hair follicles off of the body from
31 a strip of tissue, or extracts or removes hair follicles from
32 one location on a living human body for the purpose of
