Engage or hold herself or himself out as engaging in 14 (b) the business of analyzing or abstracting prepaid limited health 15 16 services contracts or of counseling or advising or giving 17 opinions to persons relative to such contracts other than as a 18 consulting actuary advising a prepaid limited health service 19 organization or as a salaried bona fide full-time employee so 20 counseling and advising her or his employer relative to coverage 21 for the employer and her or his employees.

All provisions of this chapter are applicable to 22 (5) prepaid limited health service contracts or membership services 23 which provide coverage only for costs associated with 24 25 transportation provided by ambulance services, including an air 26 ambulance service licensed pursuant to s. 401.251.
