(gggg) Omega Psi Phi Fraternity license plate, \$25.

(hhhh) Kappa Alpha Psi Fraternity license plate, \$25.

(iiii) Phi Beta Sigma Fraternity license plate, \$25.

(jjjj) Zeta Phi Beta Sorority license plate, \$25.

(kkkk) Delta Sigma Theta Sorority license plate, \$25.

(1111) Alpha Kappa Alpha Sorority license plate, \$25.

(mmmm) Sigma Gamma Rho Sorority license plate, \$25.
