19	(a) "Activities of daily living" has the same meaning as in

23	with one or more activities of daily living.
24	(c) "Vulnerable adult" has the same meaning as in s.
25	415.102.
26	(2) COMPLIANCEA county, municipality, special district as
27	defined in s. 189.012, or other political subdivision of the
28	state seeking to regulate home caregiver services must comply
29	with the requirements of this section. A local authority may not

32	(3) HOME CAREGIVER REGISTRATION PROGRAMA county,

95	with the ordinance may be reported by the public or by a
96	governmental entity.
97	(j) The implementation of an awareness or educational
98	campaign at least 6 months before the effective date of the
99	ordinance to educate the public about the registration process.
100	(4) EXEMPTIONS; EXCEPTIONSThis section may not be
101	construed as prohibiting or restricting the practice, services,

126	(5) APPLICABILITYThis section does not apply to any local
127	law, ordinance, or regulation adopted on or before June 30,

129	regulation that is more restrictive than the regulations
