11 (a) For purposes of this subsection, the term:
12 1. "Local constitutional officer" includes sheriffs, tax
13 collectors, property appraisers, supervisors of elections,
14 clerks of the circuit court, county commissioners, district
15 school board members, and superintendents of schools.
16 2. "Reporting entity" includes each municipality, county,
17 local constitutional officer, county school district, state
18 college, state university, and water management district.
19 3. "Statewide travel management system" means the system
20 used by the Department of Management Services to:
21 a. Collect and store information relating to public officer
22 or employee travel information.
23 b. Standardize and automate agency travel management.
24 c. Allow for travel planning and approval, expense
25 reporting, and reimbursement.
26 d. Allow travel information queries.
27 (b) Each executive branch state government agency and the
28 judicial branch must report on the statewide travel management
29 system all public officer and employee travel information,
30 including, but not limited to, name and position title, purpose
31 of travel, dates and location of travel, mode of travel,
32 confirmation from the head of the agency or designee
33 authorization if required, and total travel cost.
34 1. Each executive branch state government agency and the
35 judicial branch must use the statewide travel management system
36 for purposes of travel authorization and reimbursement.
37 2. By November 1, 2018, the Department of Management
38 Services shall make available to the public all travel reports
39 posted on the statewide travel management system for executive

40 branch state government agencies and the judicial branch.

41 (c) Each reporting entity must post on the statewide travel
42 management system information relating to all travel resulting
43 in an overnight stay for public officers and employees,
44 including, but not limited to, name and position title, purpose
45 of travel, dates and location of travel, mode of travel, and
46 total travel costs.

47 1. Each reporting entity shall post one travel report per
48 entity. A local constitutional officer may post a separate
49 travel report from the respective county travel report.

50 2. Every month, each reporting entity shall post a travel
51 report for the previous month.

52 3. The Department of Management Services shall provide a
53 format and method for reporting entities to post travel reports.

54 4. No later than November 1, 2019, each reporting entity
55 shall post monthly travel reports relating to all travel
56 resulting in an overnight stay for public officers and
57 employees.

58 5. Beginning December 1, 2019, the Department of Management
59 Services shall make available to the public all travel reports
60 for reporting entities which are in the statewide travel
61 management system.

62 6. The requirements of this paragraph are contingent upon
63 the Legislature appropriating at least \$5.4 million to the
64 Department of Management Services for the 2018-2019 fiscal year
65 to implement the system for the reporting entities.

66 (d) Travel reports made available on the statewide travel
67 management system may not reveal information made confidential
68 and exempt or exempt by law.

69 1. A reporting entity must redact confidential and exempt
70 or exempt information from a travel report before posting the
71 report on the statewide travel management system. If the
72 reporting entity becomes aware that an improperly redacted
73 travel report has been posted, the entity must notify the
74 Department of Management Services and immediately request
75 removal of the travel report from the statewide travel
76 management system. Within 7 business days of becoming aware that
77 an improperly redacted travel report has been posted, the entity
78 must post a properly redacted travel report on the statewide
79 travel management system.

80 2. The Secretary of Management Services or an officer, an
81 employee, or a contractor of the department is not responsible
82 for redacting confidential and exempt or exempt information from
83 a travel report posted on the statewide travel management
84 system.

85 3. The posting of travel reports on the statewide travel
86 management system or the provision of information on a website
87 for public viewing and downloading does not supersede the duty
88 of a reporting entity to respond to a public records request or
89 subpoena for the information.

90 Section 6. The Legislature finds that a proper and
91 legitimate state purpose is served when the travel records of
92 state and local employees are transparent to members of the
93 public. Therefore, the Legislature determines and declares that
94 this act fulfills an important state interest.
