county or city commission, council, or board may hold an employment or contractual relationship with a law firm when one or more of the firm's lawyers represents a client before the public officer's commission, council, or board if the public officer satisfies the following requirements every time a lawyer of the firm appears before the commission, council, or board: 1. The public officer abstains from voting on any matter in

- which the lawyer is appearing, publicly states the reason for the abstention, and provides a written disclosure as prescribed in s. 112.3143(3)(a).
- 2. The public officer recuses himself or herself from any questions, discussions, or debate on any such matter.
- 3. The public officer does not discuss any such matter with another officer of the commission, council, or board, or any staff member thereof.

28 A public officer with an employment or contractual relationship 29 with a law firm who fails to satisfy the requirements in this

30 paragraph is deemed to have violated this subsection.
