#### **SUMMARY ANALYSIS**

Foster care is care provided to a child in a foster family or boarding home, group home, agency boarding home, or child care institution. Foster homes are licensed and inspected regularly. Under current law, various information relating to a foster parent applicant, foster parent, and other family members are protected from public record requirements; however, the names of the foster parent applicant, foster parent, and other family members are public record.

The bill expands the public record exemption for a foster parent applicant, licensed foster parent, and the spouse, minor children, and other adult household members of the applicant or licensee to also protect the name of such applicant, licensee, spouse, minor child, and other adult household member. This information would be exempt from disclosure under s. 119.07(1), F.S., and Article 1, s. 24(a) of the Florida Constitution. The bill also provides that if a licensed foster partner or their spouse, minor child, or other adult household member is charged with committing a crime against a foster child who is in their care which results in the suspension or revocation of that foster parent's license, then the public records exemption that protects the names of such individuals does not apply, unless otherwise expressly made confidential or exempt by a different statute.

The bill subjects the exemption to review and repeal on October 2, 2024, pursuant to s. 119.15, F.S., the Open Government Sunset Review Act. The bill also includes a public necessity statement as required by the Florida Constitution.

The bill may have a minimal fiscal impact on the state and does not appear to have an impact on local governments. See Fiscal Comments.

Article I, s. 24(c) of the Florida Constitution requires a two-thirds vote of the members present and voting for final passage of a newly created or expanded public record or public meeting exemption. The bill expands a public record exemption; thus, it requires a two-thirds vote for final passage.

### **FULL ANALYSIS**

### I. SUBSTANTIVE ANALYSIS

## A. EFFECT OF PROPOSED CHANGES:

# **Background**

# **Child Welfare System**

The child welfare system identifies families whose children are in danger of suffering or have suffered abuse, abandonment, or neglect and works with those families to address the problems that are endangering children, if possible. If the problems cannot be addressed, the child welfare system finds safe out-of-home placements for these children. Out-of-home placements range from temporary placement with a family member, a family foster home, a residential child-caring agency, or a permanent adoptive placement with a family previously unknown to the child.<sup>1</sup>

As of January 31, 2019, 10,989 children were receiving services in their home, while 23,616 children were in out-of-home care.<sup>2</sup> Out-of-home placements range from temporary placement with a family member, a family foster home, a residential child-caring agency, or a permanent adoptive placement with a family previously unknown to the child.<sup>3</sup>

## **Foster Care**

Foster care is care provided to a child in a foster family or boarding home, group home, agency boarding home, or child care institution. A family foster home means a licensed private residence in which children who are unattended by a parent or legal guardian are provided 24-hour care. Such homes include emergency shelter family homes and specialized foster homes for children with special needs. Foster homes are licensed and inspected regularly.

The Department of Children and Families (DCF) contracts with Community-Based Care (CBC) partner agencies. The CBC's are tasked with recruiting and training families across Florida who are willing to serve as foster parents. As of November 2018, the total number of licensed foster homes was 5,358.

To qualify as a potential foster parent, applicants must go through a rigorous interview process, complete a training program, and participate in a home inspection and background check.<sup>9</sup> Foster parents are expected to:<sup>10</sup>

 Provide parenting that consists of a loving commitment to the child and the child's safety and wellbeing;

- Provide opportunities to develop the child's interests and skills;
- Care for the child in light of the child's culture, religion, ethnicity, special physical or psychological needs and unique situations;
- Assist the biological parents in improving their ability to care for and protect their children and to provide continuity for the child;
- Assist the child in visitation and other forms of communication with his or her biological family;
- Obtain and maintain records that are important to the child's wellbeing, such as medical records and records of achievements;
- Advocate for children in their care with the child welfare system, the court, and community agencies, such as schools, child care, and health providers;
- Participate fully in the child's medical, psychological, and dental care as they would for their biological child; and
- Support the child's school success by participating in school activities and meetings.

While foster parents receive a monthly stipend<sup>11</sup> to help cover costs associated with fostering a child, this funding will generally not pay for everything a foster child needs.<sup>12</sup> As of January 1, 2019, foster parents receive the following monthly room and board rates per child:<sup>13</sup>

- \$466.65 for children ages zero to five;
- \$478.60 for children ages six to twelve; and
- \$560.19 for children ages thirteen to twenty-one.

# **Public Records and Open Meetings Requirements**

The Florida Constitution provides that the public has the right to access government records and meetings. The public may inspect or copy any public record made or received in connection with the official business of any public body, officer, or employee of the state, or of persons acting on their behalf.<sup>14</sup> The public also has a right to notice and access to meetings of any collegial public body of the executive branch of state government or of any local government.<sup>15</sup> The Legislature's meetings must also be open and noticed to the public, unless there is an exception provided for by the Constitution.<sup>16</sup>

Additionally, Florida Statutes specify conditions under which public access must be provided to government records and meetings. The Public Records Act<sup>17</sup> guarantees every person's right to inspect and copy any state or local government public record. The Sunshine Law<sup>19</sup> requires all meetings of

any board or commission of any state or local agency or authority at which official acts are to be taken be noticed and open to the public.<sup>20</sup>

The Legislature may create an exemption to public records or open meetings requirements.<sup>21</sup> An exemption must specifically state the public necessity justifying the exemption<sup>22</sup> and must be tailored to accomplish the stated purpose of the law.<sup>23</sup> There is a difference between records the Legislature has determined to be exempt from the Public Records Act and those which the Legislature has determined to be confidential and exempt.<sup>24</sup>

# **Open Government Sunset Review Act**

The Open Government Sunset Review Act (OGSR) prescribes a legislative review process for newly created or substantially amended public records or open meetings exemptions. The OGSR provides that an exemption automatically repeals on October 2nd of the fifth year after creation or substantial amendment; in order to save an exemption from repeal, the Legislature must reenact the exemption.

The OGSR provides that a public records or open meetings exemption may be created or maintained only if it serves an identifiable public purpose and is no broader than is necessary.<sup>27</sup> An exemption serves an identifiable purpose if it meets one of the following criteria:

- It allows the state or its political subdivision to effectively and efficiently administer a program, and administration would be significantly impaired without the exemption; or
- Releasing sensitive personal information would be defamatory or would jeopardize an
  individual's safety. If this public purpose is cited as the basis of an exemption, however, only
  personal identifying information is exempt; or
- It protects trade or business secrets.<sup>28</sup>

In addition, the Legislature must find that the identifiable public purpose is compelling enough to override Florida's open government public policy and that the purpose of the exemption cannot be accomplished without the exemption.<sup>29</sup>

# **Foster Parent Public Record Exemption**

Section 409.175, F.S., addresses the licensure of family foster homes. The following information held by DCF relating to a foster parent applicant and the applicant's spouse, minor child, and other adult household members is exempt from public records:<sup>30</sup>

- Home, business, work, child care, or school addresses and telephone numbers;
- Birth dates:
- Medical records;
- Floor plans of the home; and
- Photographs of such persons.

If a foster parent applicant does not receive a license, this information becomes public five years after the date of application. However, medical records remain exempt regardless of licensure.<sup>31</sup>

For a licensed foster parent and the foster parent's spouse, minor child, and other adult household member, the same information is exempt.<sup>32</sup> If a foster parent's license is no longer active, this information becomes public five years after the license's expiration date, subject to two exceptions: medical records remain exempt regardless of the license's status and all of this information remains exempt if a licensed foster parent becomes an adoptive parent.<sup>33</sup>

The original public records exemption for foster parents passed in 1998 and initially applied only to certain information contained in the licensing file for licensed foster parents.<sup>34</sup> The public necessity statement expressed concern that foster parents and their families may be threated, harassed, or harmed if personal information were released.<sup>35</sup> It also included findings that potential foster parents might be reluctant to reveal information necessary to evaluate their abilities to make appropriate placements for children and the public availability would have a negative effect on foster parent recruitment and retention.<sup>36</sup>

During the Open Government Sunset Review in 2003, the Legislature expanded the exemption to include families who were pending licensure or had been denied, thus protecting their information as well, and to include medical records.<sup>37</sup> The Legislature also removed the requirement that the information be in the licensing file to be protected and instead protected the information as long as it was held by DCF.<sup>38</sup> The public necessity statement cited the private and confidential nature of personal health matters and the potential negative effect on recruitment.<sup>39</sup> The expansion of the public records exemption was reviewed in 2008 and resulted in the Legislature saving the exemption from repeal with only minor amendments.<sup>40</sup>

# **Violence against Foster Parents**

In August 2018, a biological mother shot a 77-year-old foster parent in Florida during an armed burglary of the foster parent's home where the biological mother's two children had been placed. When the foster parent refused to let the biological mother leave with her two children, a struggle ensued, and

biological mother shot the foster mother twice. The biological mother was charged with attempted first-degree murder with a deadly weapon, two counts of conspiracy to kidnap, and armed burglary.<sup>41</sup>

DCF released a statement that no personal information about the 77-year-old foster parent was released by DCF. However, in light of the incident, DCF refused a public record request for a list of names of all licensed foster parents and their corresponding counties as DCF was unable to ensure that the release of this information would not jeopardize the safety of foster parents or the children in their care. After this, several foster parents contacted DCF with concerns about the potential release of their names, stating that they would no longer choose to be foster parents if that occurred. As

# **Effect of Proposed Changes**

The bill expands the information of foster parents and applicants that is confidential and exempt from disclosure under s. 119.07(1), F.S., and Article I, s. 24(a) of the Florida Constitution. Specifically, the bill adds the names of licensed foster parents, foster parent applicants, and their spouse, minor child, and other adult household members to the public records exemption. The bill also provides that if a licensed foster partner or their spouse, minor child, or other adult household member, is charged with committing a crime against a foster child who is in their care, which results in the suspension or revocation of that foster parent's license, then the public records exemption for the names of such individuals does not apply, unless otherwise expressly made confidential or exempt by a different statute.

The bill provides that the expansion of the public records exemption is subject to review and repeal on October 2, 2024, in accordance with s. 119.15, F.S., the Open Government Sunset Review Act.

The bill also includes a public necessity statement as required by the Florida Constitution which states that this exemption will ensure that private and sensitive information regarding foster children remains exempt. If a foster parent applicant, licensed foster parent, or any associated person as described in s. 409.175, F.S., has an unusual name, this information could be used to obtain information on the foster child, such as the child's name or location. The public necessity statement provides that there are instances in which foster parents find themselves and their families in life-threatening situations, such as a case in August 2018, in which a foster mother was harmed by the foster child's biological parents. Additionally, the public necessity statement provides that the disclosure of the names of foster parent applicants, licensed foster parents, or any associated person as described in s. 409.175, F.S., would compromise the family's privacy and stifle DCF's efforts to recruit and retain foster parent applicants and licensed foster parents.

The bill takes effect on July 1, 2019.

# D. FISCAL COMMENTS:

The bill could have a minimal fiscal impact on DCF because agency staff responsible for complying with public record requests may require training related to the expansion of the public record exemption. In addition, DCF could incur costs associated with redacting the exempt information prior to releasing a record. The costs, however, would be absorbed, as they are part of the day-to-day responsibilities of the department.

### Vote Requirement

Article I, s. 24(c) of the State Constitution requires a two-thirds vote of the members present and voting for final passage of a newly created public record or public meeting exemption. The bill expands a new public records exemption; thus, it requires a two-thirds vote for final passage.

### **Public Necessity Statement**

Article I, s. 24(c) of the State Constitution requires a public necessity statement for a newly created or expanded public record or public meeting exemption. The bill expands a new public records exemption; thus, it includes a public necessity statement.

# Breadth of Exemption

Article I, section 24(c) of the State Constitution requires a newly created or expanded public record exemption to be no broader than necessary to accomplish the stated purpose of the law. The bill limits the public record exemption to the names of the foster parent and foster parent applicants, spouses, minor child and other adult household members of such foster parents and foster parent applicants. As such, the exemption does not appear to be to be in conflict with the constitutional requirement that it be no broader than necessary to accomplish its purpose.

## B. RULE-MAKING AUTHORITY:

The bill does not appear to create a need for rule-making or rule-making authority.

# C. DRAFTING ISSUES OR OTHER COMMENTS:

### IV. AMENDMENTS/ COMMITTEE SUBSTITUTE CHANGES

On March 25, 2019, the Oversight, Transparency & Public Management Subcommittee adopted an amendment and reported the bill favorably as a committee substitute. The amendment provides that if a licensed foster partner or their spouse, minor child, or other adult household member is charged with committing a crime against a foster child who is in their care, which results in the suspension or revocation of that foster parent's license, then the public records exemption for the names of such individuals does not apply, unless otherwise expressly made confidential or exempt by a different statute.
