# I. Summary:

SB 316 provides for an annual use fee of \$25 for the Toastmasters specialty license plate.

Senate Bill 314 (2020), which this bill is linked to, creates the Toastmasters specialty license plate and provides for the design of the plate and the use of the annual fees associated with the specialty license plate.

According to the Department of Highway Safety and Motor Vehicles (DHSMV), the bill will have a negative, but insignificant fiscal impact associated with programming costs. These costs can be absorbed within existing resources.

The bill has an effective date on the same date that SB 314 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law.

# II. Present Situation:

# **Specialty License Plates**

Presently, there are over 120 specialty license plates available for purchase in Florida<sup>1</sup>. Specialty license plates are available to an owner or lessee of a motor vehicle who is willing to pay an annual use fee, ranging from \$15 to \$25, paid in addition to required license taxes and service fees.<sup>2</sup> The annual use fees are distributed to an organization or organizations in support of a particular cause or charity signified on the plate's design and designated in statute.<sup>3</sup>

In order to establish a specialty license plate and after the plate is approved by law, s. 320.08053, F.S., requires the following actions within certain timelines:

- Within 60 days, the organization must submit an art design for the plate, in a medium prescribed by the DHSMV;
- Within 120 days, the DHSMV must establish a method to issue pre-sale vouchers for the specialty license plate; and
- Within 24 months after the pre-sale vouchers are established, the organization must obtain a minimum of 1,000 voucher sales before manufacturing of the plate may begin.

If the minimum sales requirement has not been met by the end of the 24-month pre-sale period, then the DHSMV will discontinue the plate and issuance of pre-sale vouchers. Upon discontinuation, a purchaser of a presale voucher may use the annual use fee as a credit towards any other specialty license plate or apply for a refund with the DHSMV.<sup>4</sup>

The annual use fees collected by an organization and any interest earned from the fees may be expended only for use in this state unless the annual use fee is derived from the sale of specified United States Armed Forces and veterans-related specialty plates.<sup>5</sup> Additionally, organizations must adhere to certain accountability requirements, including an annual audit or attestation document affirming that funds received have been spent in accordance with applicable statutes.<sup>6</sup>

# DHSMV Costs Defrayed

The DHSMV is authorized to retain a sufficient portion of annual use fees collected from the sale of specialty plates to defray its costs for inventory, distribution, and other direct costs associated with the specialty license plate program. The remainder of the proceeds collected are distributed as provided by law.<sup>7</sup>

# Discontinuance of Specialty Plates

The DHSMV must discontinue the issuance of an approved specialty license plate if the number of valid registrations falls below 1,000 plates for at least 12 consecutive months. A warning letter is mailed to the sponsoring organization following the first month in which the total number of valid specialty license plate registrations is below 1,000 plates. Collegiate plates for Florida universities are exempt from the minimum specialty license plate requirement.<sup>8</sup> In addition, the DHSMV is authorized to discontinue any specialty license plate if the organization no longer exists, stops providing services that are authorized to be funded from the annual use fee proceeds, or pursuant to an organizational recipient's request.<sup>9</sup>

# **Toastmasters International**

Toastmasters began as a series of speaking clubs organized by Ralph C. Smedley during his time working for the YMCA (Young Men's Christian Association). Smedley was director of education at the YMCA and he saw a need for the men in the community to learn how to speak, conduct meetings, plan programs and work on committees. He decided to organize a club where they could learn these skills in a social environment. He named this group the Toastmasters Club; "toastmaster" was a popular term that referred to a person who gave toasts at banquets and other occasions.<sup>10</sup>

Since 1924, Toastmasters International has helped people from diverse backgrounds become more confident speakers, communicators, and leaders. Toastmasters International is a non-profit educational organization that teaches public speaking and leadership skills through a worldwide network of clubs. The organization's membership exceeds 358,000 in 142 countries.<sup>11</sup>

Toastmasters International is not listed in the Department of State Division of Corporations sunbiz.org database as a Florida business entity.

# Ralph C. Smedley Memorial Fund

In 1965 the Ralph C. Smedley Memorial Fund was established to honor and uphold Ralph C. Smedley's legacy and to open doors for the many millions of potential Toastmaster yet to come. Though the historic fund had humble beginnings with a local impact, the reinvigorated Smedley Fund retains its same purpose—the advancement of communication and leadership education through the research, development, and distribution of educational programs and materials.<sup>12</sup>

# III. Effect of Proposed Changes:

The bill provides for an annual fee of \$25 for the Toastmasters specially license plate.

This bill has an effective date of October 1, 2020, but only if SB 314 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes law.

D. State Tax or Fee Increases:

Under the 2018 amendment to the Florida Constitution, Article VII, Section 19 requires "a supermajority vote" of 2/3 of the membership of each house to pass legislation which will impose or authorize a new state tax or fee.<sup>13</sup> A "fee" is defined as "any charge or payment required by law, including any fee for service, fee or cost for licenses, and charge for service."<sup>14</sup>

The \$25 annual use fee for the Toastmaster specialty license plate may be a new state fee for purposes of requiring a supermajority vote and a separate bill containing no other subject.

E. Other Constitutional Issues:

# V. Fiscal Impact Statement:

A. Tax/Fee Issues:

Individuals who choose to purchase a Toastmasters specialty license plate will pay an additional use fee of \$25 in addition to required vehicle license taxes and fees.

B. Private Sector Impact:

Revenue from the sale of the Toastmasters license plate will benefit Toastmasters International and those who are eligible to participate in their programs.

C. Government Sector Impact:

The DHSMV is authorized to retain revenues from the first proceeds of specialty license plate sales to defray departmental expenditures related to the specialty license plate program.<sup>15</sup>
