20	College, in which Florida has 29 electors, would further enable					
21	the destruction of the remaining balance of power between the 50					
22	states and the Federal Government and effectively dissolve the					
23	United States constitutional republic, and					
24	WHEREAS, abolishment of the Electoral College would					
25	conceivably provide the impetus to force this state to pass a

26 bill implementing the National Popular Vote Interstate Compact
27 (NPVIC), and

28 WHEREAS, the NPVIC requires the electors of participating 29 states to vote for the candidates for President and Vice 30 President who receive the overall popular vote in the United 31 States instead of allowing individual states to determine how to 32 allocate their electoral votes on the basis of statewide voting 33 results, and

34 WHEREAS, the enactment of a bill implementing the NPVIC 35 opens the door to an ever-increasing problem of votes being cast 36 by illegal voters thereby creating a vastly inaccurate 37 representation of bonafide United States citizens, and

38 WHEREAS, proposing and passing a resolution to support, 39 protect, and defend the United States Constitution and preserve 40 the Electoral College will properly and accurately be a true 41 representation to Florida citizens that gives voters the 42 confidence of knowing their duly elected legislators will honor 43 their oath of office, NOW, THEREFORE,
