Comprehensive health education that addresses concepts of community health; consumer health; environmental health; family life, including an awareness of the benefits of sexual abstinence as the expected standard and the consequences of teenage pregnancy; the full range of contraceptive methods available to prevent pregnancy; mental and emotional health; injury prevention and safety; Internet safety; nutrition; personal health; prevention and control of disease; and substance use and abuse. The health education curriculum for students in grades 7 through 12 shall include a teen dating violence and abuse component that includes, but is not limited to, the definition of dating violence and abuse, the warning signs of dating violence and abusive behavior, the characteristics of healthy relationships, measures to prevent and stop dating violence and abuse, and community resources available to victims of dating violence and abuse. The Department of Health, in consultation with the department, shall develop instructional materials regarding the full range of contraceptive methods available to prevent pregnancy, including the efficacy of each method, which must be in easily comprehensible language and include only medically accurate, evidence-based information. School districts shall include the instructional materials in their health education curriculum.
