19	area under this section, the department, in consultation with
20	the Division of Emergency Management, must consider the extent
21	to which such site:
22	(a) Is located in a geographic area that best facilitates
23	the wide dissemination of emergency-related supplies and
24	equipment;
25	(b) Provides ease of access to major highways and other
26	transportation facilities;
27	(c) Is sufficiently large to accommodate the staging of a
28	significant amount of emergency-related supplies and equipment;
29	(d) Provides space in support of emergency preparedness and
30	evacuation activities, such as fuel reserve capacity;
31	(e) Could be used during nonemergency periods for
32	commercial motor vehicle parking and for other uses; and
33	(f) Is consistent with other state and local emergency
34	management considerations.

36	The department must give priority consideration to placement of
37	such staging areas in counties with a population of 200,000 or
38	fewer, as determined by the most recent official estimate
39	pursuant to s. 186.901, in which a multiuse corridor of regional
40	economic significance, as provided in s. 338.2278, is located.
