The Committee on Appropriations (Gibson) recommended the following:

**Senate Amendment (with title amendment)**

Delete lines 28 - 69

and insert:

(b) "Health care provider" means a physician or physician assistant licensed under chapter 458 or chapter 459 or an advanced practice registered nurse registered under chapter 464.

(c) "Uterine fibroid" means a noncancerous growth of the uterus that often appears during a woman's childbearing years.

(2) UTERINE FIBROID RESEARCH DATABASE.-

11       (a) The department shall develop and maintain an electronic  
12 database consisting of information related to uterine fibroids.  
13 The purpose of the database is to encourage research relating to  
14 the diagnosis and treatment of uterine fibroids and to ensure  
15 that women are provided with the relevant information and health  
16 care necessary to prevent and treat uterine fibroids. The  
17 database must include, but need not be limited to, all of the  
18 following information:

19       1. Incidence and prevalence of women diagnosed with uterine  
20 fibroids in this state.

21       2. Demographic attributes of women diagnosed with uterine  
22 fibroids in this state.

23       3. Treatments and procedures for uterine fibroids used by  
24 health care providers in this state.

25       (b) A health care provider who diagnoses or treats a woman  
26 with uterine fibroids shall submit information relating to such  
27 diagnosis or treatment to the department in a form and manner  
28 prescribed by department rule for inclusion in the database.  
29 Such information may be submitted along with any reports or  
30 other information that the health care provider is required to  
31 submit to the department pursuant to state law.

32       (c) The database may not include any personal identifying  
33 information of women diagnosed with or treated for uterine  
34 fibroids.

35       (3) UTERINE FIBROID EDUCATION OUTREACH AND PUBLIC  
36 AWARENESS.—The department shall develop and include information  
37 related to uterine fibroids in its women's health care  
38 educational materials currently made available to the public.  
39 The information must include, but need not be limited to, the



40 following:

41 (a) Possible risk factors for developing uterine fibroids.

42 (b) Range of available treatment options that are

43 considered alternatives to hysterectomy.

44 Section 2. For the 2022-2023 fiscal year, the sums of  
45 \$121,852 in recurring funds and \$681,048 in nonrecurring funds  
46 from the General Revenue Fund are appropriated to the Department  
47 of Health and one full-time equivalent position with associated  
48 salary rate of 55,212 is authorized for the purpose of  
49 implementing this act.
