458.3475 Anesthesiologist assistants.-

- DEFINITIONS.—As used in this section, the term:
- "Anesthesiologist" means an allopathic or osteopathic (a) physician who holds an active, unrestricted license; who has successfully completed an anesthesiology training program approved by the Accreditation Council on Graduate Medical
