An act relating to bingo; amending s. 849.0931, F.S.; revising the definition of "bingo card"; defining the term "bingo card minder"; renaming "instant bingo" as "pull tab game"; requiring that bingo card minder software be certified; requiring that such certification be available upon request; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (14) of section 849.0931, Florida Statutes, is renumbered as subsection (15), subsections (1) and (2), (5) through (11), and (13) are amended, and a new subsection (14) is added to that section, to read:
849.0931 Bingo authorized; conditions for conduct; permitted uses of proceeds; limitations.-
(1) As used in this section:
(a) "Bing game" means and refers to the activity,
eommonly known as "bingo," in which participants pay a sum of money for the use of one or more bingo cards. When the game eommences, numbers are drawn by chance, one by one, and announced. The players cover or marl those numbers on the bingo eards which they have purchased until a player receives a given order of numbers in sequence that has been preannounced for that

particular game. This player calls out "bingo" and is declared the winner of a predetermined prize. More than one game may be played upon a bingo card, and numbers alled for one game may be used for a succeding game or games.
(a) (b) "Bingo card" means and refers to the flat piece of paper, of thin pasteboard, or electronic facsimile employed by players engaged in the game of bingo. The bingo card shall have not fewer than 24 playing numbers printed on it. These playing numbers shall range from 1 through 75, inclusive. More than one set of bingo numbers may be printed on any single piece of paper.
(b) "Bingo card minder" means a device that keeps track of players' bingo cards and the numbers called during live caller bingo games.
(c) "Bingo game" means and refers to the activity, commonly known as "bingo," in which participants pay a sum of money for the use of one or more bingo cards. When the game commences, numbers are drawn by chance, one by one, and announced. The players cover or mark those numbers on the bingo cards which they have purchased until a player receives a given order of numbers in sequence that has been preannounced for that particular game. This player calls out "bingo" and is declared the winner of a predetermined prize. More than one game may be played upon a bingo card, and numbers called for one game may be used for a succeeding game or games.

(d)(c) "Charitable, nonprofit, or veterans' organization" means an organization which has qualified for exemption from federal income tax as an exempt organization under the provisions of s. 501(c) of the Internal Revenue Code of 1954 or s. 528 of the Internal Revenue Code of 1986 , as amended; which is engaged in charitable, civic, community, benevolent, religious, or scholastic works or other similar activities; and which has been in existence and active for a period of 3 years or more.
(e)(d) "Deal" means a separate set or package of not more than 4,000 pull tab game instant binge tickets in which the predetermined minimum prize payout is at least 65 percent of the total receipts from the sale of the entire deal.
(f)(c) "Flare" means the board or placard that accompanies each deal of pull tab game instant binge tickets and that has printed on or affixed to it the following information:

1. The game name.
2. The manufacturer's name or distinctive logo.
3. The form number.
4. The ticket count.
5. The prize structure, including the number of symbols or number combinations for winning pull tab game instant binge tickets by denomination, with their respective winning symbols or number combinations.
6. The cost per play.

7. The game serial number.
(f) "Instant bingo" means a form of bingo that is played at the same location as bingo, using tickets by which a playex wins a prize by opening and removing a cover from the ticket to reveal a set of numbers, letters, objects, or patterns, some of which have been designated in advance as prize winners.
(g) "Objects" means a set of 75 balls or other precision shapes that are imprinted with letters and numbers in such a way that numbers 1 through 15 are marked with the letter "B," numbers 16 through 30 are marked with the letter "I," numbers 31 through 45 are marked with the letter "N," numbers 46 through 60 are marked with the letter "G," and numbers 61 through 75 are marked with the letter "O."
(h) "Pull tab game" means a form of bingo that is played at the same location as bingo, using tickets by which a player wins a prize by opening and removing a cover from the ticket to reveal a set of numbers, letters, objects, or patterns, some of which have been designated in advance as prize winners.
(i) (h) "Rack" means the container in which the objects are placed after being drawn and announced.
(j)(i) "Receptacle" means the container from which the objects are drawn or ejected.
(k)(j) "Session" means a designated set of games played in a day or part of a day.
(2)(a) None of the provisions of this chapter shall be

construed to prohibit or prevent charitable, nonprofit, or veterans' organizations engaged in charitable, civic, community, benevolent, religious, or scholastic works or other similar endeavors, which organizations have been in existence and active for a period of 3 years or more, from conducting bingo games or pull tab games instant binge, provided the entire proceeds derived from the conduct of such games, less actual business expenses for articles designed for and essential to the operation, conduct, and playing of bingo or pull tab games instant binge, are donated by such organizations to the endeavors mentioned above. In no case may the net proceeds from the conduct of such games be used for any other purpose whatsoever. The proceeds derived from the conduct of bingo games or pull tab games instant binge shall not be considered solicitation of public donations.
(b) It is the express intent of the Legislature that no charitable, nonprofit, or veterans' organization serve as a sponsor of a bingo game or a pull tab game instant bingo conducted by another, but such organization may only be directly involved in the conduct of such a game as provided in this act.
(5) Except for pull tab game instant binge prizes, which are limited to the amounts displayed on the ticket or on the game flare, a jackpot shall not exceed the value of $\$ 500$ \$250 in actual money or its equivalent, and there shall be no more than three jackpots in any one session of bingo.

(6) Except for pull tab games instant binge, which are is not limited by this subsection, the number of days per week during which organizations authorized under this section may conduct bingo shall not exceed two.
(7) Except for pull tab game instant binge prizes, which are limited to the amounts displayed on the ticket or on the game flare, there shall be no more than three jackpots on any one day of play. All other game prizes shall not exceed $\$ 100$ $\$ 50$ 。
(8) Each person involved in the conduct of any bingo game or pull tab game instant binge must be a resident of the community where the organization is located and a bona fide member of the organization sponsoring such game and may not be compensated in any way for operation of such game. When bingo games or pull tab games are instant bingo is conducted by a charitable, nonprofit, or veterans' organization, the organization conducting the games must designate up to three members of that organization to be in charge of the games, one of whom shall be present during the entire session at which the games are conducted. The organization conducting the games is responsible for posting a notice, which notice states the name of the organization and the designated member or members, in a conspicuous place on the premises at which the session is held or pull tab games are instant bingo is played. A caller in a bingo game may not be a participant in that bingo game.

(9) Every charitable, nonprofit, or veterans' organization involved in the conduct of a bingo game or pull tab game instant ing must be located in the county, or within a 15 -mile radius of, where the bingo game or pull tab game instant binge is located.
(10)(a) No one under 18 years of age shall be allowed to play any bingo game or pull tab game instant binge or be involved in the conduct of a bingo game or a pull tab game instant binge in any way.
(b) Any organization conducting bingo open to the public may refuse entry to any person who is objectionable or undesirable to the sponsoring organization, but such refusal of entry shall not be on the basis of race, creed, color, religion, sex, national origin, marital status, or physical handicap.
(11) Bingo games or pull tab games instant binge may be held only on the following premises:
(a) Property owned by the charitable, nonprofit, or veterans' organization.
(b) Property owned by the charitable, nonprofit, or veterans' organization that will benefit by the proceeds.
(c) Property leased for a period of not less than 1 year by a charitable, nonprofit, or veterans' organization, providing the lease or rental agreement does not provide for the payment of a percentage of the proceeds generated at such premises to the lessor or any other party and providing the rental rate for

such premises does not exceed the rental rates charged for similar premises in the same locale.
(d) Property owned by a municipality or a county when the governing authority has, by appropriate ordinance or resolution, specifically authorized the use of such property for the conduct of such games.
(e) With respect to bingo games conducted by a condominium association, a cooperative association, a homeowners' association as defined in s. 720.301, a mobile home owners' association, a group of residents of a mobile home park as defined in chapter 723, or a group of residents of a mobile home park or recreational vehicle park as defined in chapter 513, property owned by the association, property owned by the residents of the mobile home park or recreational vehicle park, or property which is a common area located within the condominium, mobile home park, or recreational vehicle park.
(13)(a) Pull tab game instant binge tickets must be sold at the price displayed printed on the ticket or on the game flare by the manufacturer, not to exceed \$1. Discounts may not be given for the purchase of multiple tickets, nor may tickets be given away free of charge.
(b) Each deal of pull tab game instant binge tickets must be accompanied by a flare, and the flare must be available posted before the sale of any tickets in that deal.
(c) Each pull tab game instant binge ticket in a deal must

bear the same serial number, and there may not be more than one serial number in each deal. Serial numbers printed on a deal of pull tab game bing tickets may not be repeated by the manufacturer on the same form for a period of 3 years.
(d) The serial number for each paper pull tab game deal must be clearly and legibly placed on the outside of each deal's package, box, or other container.
(e) Pull tab game instant binge tickets manufactured, sold, or distributed in this state must comply with the applicable standards on pull-tabs of the North American Gaming Regulators Association, as amended.
(f) Except as provided under paragraph (e), a pull tab game instant binge ticket manufactured, sold, or distributed in this state must:

1. Be manufactured so that it is not possible to identify whether it is a winning or losing pull tab game instant bing ticket until it has been opened by the player as intended.
2. If it is a paper pull tab game ticket, be manufactured using at least a two-ply paper stock construction so that the pull tab game instant bing ticket is opaque.
3. Have the form number, the deal's serial number, and the name or logo of the manufacturer conspicuously printed on the face or cover of the pull tab game instant bing ticket.
4. Have a form of winner protection that allows the organization to verify, after the pull tab game instant bingo

ticket has been played, that the winning pull tab game instant binge ticket presented for payment is an authentic winning pull tab game instant bicket for the deal in play. The manufacturer shall provide a written description of the winner protection with each deal of pull tab game instant binge tickets.
(g) Each manufacturer and distributor that sells or distributes pull tab game instant binge tickets in this state to charitable, nonprofit, or veterans' organizations shall prepare an invoice that contains the following information:

1. Date of sale.
2. Form number and serial number of each deal sold.
3. Number of pull tab game instant bing tickets in each deal sold.
4. Name of distributor or organization to whom each deal is sold.
5. Price of each deal sold.

All information contained on an invoice must be maintained by the distributor or manufacturer for 3 years.
(h) The invoice, or a true and accurate copy thereof, must be on the premises where any deal of pull tab game instant binge ickets is stored or in play.
(14) If a bingo card minder is available, the software used by the bingo card minder must be certified to be compliant
