However, the limitation on 18 19 contributions to such political committees no longer applies 20 once the Secretary of State has issued a certificate of ballot 21 position and a designating number for the proposed amendment 22 that the political committee is sponsoring or opposing. 23 Candidates for the offices of Governor and Lieutenant Governor 24 on the same ticket are considered a single candidate for the 25 purpose of this section. 26
