Section 1. Subsections (5) and (6) of section 83.56, Florida Statutes, are redesignated as subsections (6) and (7), respectively, and a new subsection (5) is added to that section, to read:

(5) Notwithstanding any other law to the contrary, if the landlord knows or reasonably should know that the tenant is pregnant or there are children under 18 years of age living in the dwelling unit, the landlord must provide the tenant at least 3 months after delivery of a written notice under subsection (2) or subsection (3) to vacate the premises before bringing an

action for possession of the dwelling unit under s. 83.59.
