Has Received a doctoral degree in social work from a graduate school of social work which at the time the applicant graduated was accredited by an accrediting agency recognized by the United States Department of Education or has received a master's degree in social work from a graduate school of social work which at the time the applicant graduated:

a. Was accredited by the Council on Social Work Education;
b. Was accredited by the Canadian Association of Schools
of Social Work; or

c. Has been determined to have been a program equivalent to programs approved by the Council on Social Work Education by the Foreign Equivalency Determination Service of the Council on Social Work Education. An applicant who graduated from a program at a university or college outside of the United States or Canada must present documentation of the equivalency determination from the council in order to qualify.

The applicant's graduate program must have emphasized 34 direct clinical patient or client health care services, 35 including, but not limited to, coursework in clinical social 36 work, psychiatric social work, medical social work, social 37 casework, psychotherapy, or group therapy.
