Section 2. The Legislature finds that it is a public necessity that certain information relating to communications services locations, project proposals, and challenges submitted to and held by the Department of Economic Opportunity under the Broadband Opportunity Program or pursuant to a federal broadband access grant program implemented by the department be made confidential and exempt from public records requirements. Such information contains security information and proprietary business information of communications services providers. The disclosure of sensitive information relating to the location, capacity, features, functions, and security of these networks could result in the identification of vulnerabilities in such networks and allow a security breach that could damage the networks or disrupt the networks' safe and reliable operation, adversely impacting the public health and safety of this state. Further, the disclosure of such information would adversely affect the business interests and compromise the network security of the communications services providers and their networks. Therefore, the Legislature finds that it is a public necessity that certain information relating to communications services locations, project proposals, and challenges submitted to and held by the Department of Economic Opportunity under the
