16	Section 1. Section 252.3712, Florida Statutes, is created
17	to read:
18	252.3712 Nonprofit Security Grant Program
19	(1) The division shall establish a Nonprofit Security Grant
20	Program that shall consist of funds appropriated by the
21	Legislature to nonprofit organizations, including houses of
22	worship and community centers, that are at high risk for violent
23	attacks or hate crimes. The grants may be used to increase
24	security and safety, including, but not limited to:
25	(a) The purchase and installation of security
26	infrastructure, perimeter lighting, door hardening, security
27	camera systems, perimeter fencing, barriers and bollards, and
28	blast-resistant film and shatter-resistant glass for windows.
29	(b) Hiring security personnel.

30	(c) Training for security personnel and staff on threat
31	awareness, emergency procedures, and first aid.
32	(2) The minimum amount of any grant award is \$10,000, and
33	the maximum grant award amount is \$150,000. The total amount of
34	funds available for the program is limited to the amount
35	appropriated by the Legislature.
36	(3) The division may use up to 3 percent of the total
37	amount appropriated to administer the grant program.
38	(4) The division shall adopt rules to administer this
39	section, including rules providing for all of the following:
40	(a) Criteria for the awarding of grant funds to an owner of
41	a facility for hardening security measures.
42	(b) Criteria for the awarding of grant funds to an owner or
43	a renter of a facility for nonhardening security measures.
44	(c) Criteria for establishing the need for grant funds to
45	be awarded to an owner or a renter of a facility that has been
46	operational for a period of at least 6 months or that has
47	received a sufficient number of threats.
48	(5) This section is repealed January 1, 2028, unless
49	reviewed and saved from repeal through reenactment by the
50	Legislature.
51	Section 2. For the 2023-2024 fiscal year, the sum of $$15$
52	million in nonrecurring funds is appropriated from the General
53	Revenue Fund to the Division of Emergency Management for the
54	purpose of implementing this act.
55	Section 3. This act shall take effect July 1, 2023.
