I. Summary:

SB 2506 revises the term "Capitol Complex," in s. 281.01, F.S., for the purposes of memorials, to include the Holland Building, Elliot Building, and the associated parking garages, and modifies the boundaries of the Capitol Complex to include the state-owned lands and public streets adjacent within an area bounded by and including Calhoun Street, East Pensacola Street, Monroe Street, Jefferson Street, Duval Street, and Gaines Street.

In addition, the bill designates a specified portion of the Capitol Complex as "Memorial Park." Authorized monuments must be placed within Memorial Park. The bill provides the Capitol Police are responsible for providing and maintaining the security of Memorial Park, including providing security and protection for state officials, employees, and visitors to Memorial Park.

The bill takes effect July 1, 2023.

II. Present Situation:

Managing the Capitol Center

Chapter 272, F.S., provides that the Capitol Center¹ is under the general control and supervision of the Department of Management Services (DMS),² which includes the management and maintenance of both the grounds and buildings.³ The DMS is authorized to allocate space in the specified buildings to house various departments, agencies, boards, and commissions except the Supreme Court Building.⁴ Additionally, the DMS has the authority to provide for the

establishment of parks, walkways, and parkways on the grounds of the Capitol Center.⁵ This responsibility has historically included assistance in establishing and maintaining public memorials throughout the Capitol Center, including project management oversight of the design and construction of memorials.⁶

The term "Capitol Complex" is defined to include:

that portion of Tallahassee, Leon County, Florida, commonly referred to as the Capitol, the Historic Capitol, the Senate Office Building, the House Office Building, the Knott Building, the Pepper Building, the Holland Building, and the curtilage of each, including the state-owned lands and public streets adjacent thereto within an area bounded by and including Monroe Street, Jefferson Street, Duval Street, and Gaines Street. The term shall also include the State Capital Circle Office Complex located in Leon County, Florida.⁷

The management, maintenance, and upkeep of the Capital Complex is the obligation of the DMS, which has authority to employ a superintendent of the grounds and other employees, and is authorized to designate or appoint a nonsalaried advisory committee to advise them.⁸

Capitol Complex Monuments

A monument is defined as "a marker, statue, sculpture, plaque, or other artifice, including living plant material, placed in remembrance or recognition of a significant person or event in Florida history." The DMS is required to set aside an area of the Capitol Complex to dedicate a memorial garden on which authorized monuments must be placed. The construction and placement of a monument on the premises of the Capitol Complex is prohibited unless authorized by general law. Additionally, the construction and placement of a monument on the premises of the Capitol Complex must be approved, after considering the recommendations of DMS and the Florida Historical Commission¹¹, by the following persons:

- The Governor, or his or her designee.
- The Attorney General, or his or her designee.
- The Chief Financial Officer, or his or her designee.
- The Commissioner of Agriculture, or his or her designee.
- The President of the Senate, or his or her designee.
- The Speaker of the House of Representatives, or his or her designee. 12

Also, the DMS must coordinate with the Division of Historical Resources of the Department of State regarding a monument's design and placement.¹³

To date, there have been 13 memorials authorized by general law. Of the 13, eight have been completed, three have been funded, and two have not been funded. The following chart shows each statutorily authorized memorial.¹⁴

III. Effect of Proposed Changes:

Capitol Complex Definitions and Monuments

The bill amends ss. 272.09, and 281.01 F.S., to modify the definition of the term "Capitol Complex" to include the Holland Building, the Elliot Building, and their associated parking garages. To effectuate this change, the bill expands the area of the Capitol Complex to include the state-owned lands and public streets adjacent within an area bounded by and including Calhoun Street, East Pensacola Street, Monroe Street, Jefferson Street, Duval Street, and Gaines Street.

The bill amends s. 265.111, F.S., to remove the requirement that the DMS, in consultation with the Florida Historical Commission, dedicate an area of the Capitol Complex as a memorial garden. Instead, the bill requires the DMS to set aside and dedicate an area of the Capitol Complex to be known as "Memorial Park." The bill defines "Memorial Park" as the portion of the Capitol Complex existing between and including the Elliot Building and the Holland Building within an area bounded by and including Monroe Street, Gaines Street, Calhoun Street, and East Pensacola Street. Authorized monuments must be placed within Memorial Park. In addition, the bill provides that the Capitol Police are responsible for providing and maintaining the security of the area of the Capitol Complex known as "Memorial Park," including providing security and protection for state officials, employees, and visitors.

SB 2500, the Senate proposed General Appropriations Act (GAA), provides \$2 million from the Architects Incidental Trust Fund to the DMS for the demolition of the Elliot Building located in Leon County and the creation of the Memorial Park. The proviso states that, from the funds, \$1 million shall be placed in reserve. The DMS is authorized

to submit budget amendments to request release of funds. The budget amendment must include the design of the Memorial Park with the recommended placement of all authorized memorials. Funding is contingent upon this bill or similar legislation becoming a law.
