Obtains and carries in full force and effect a policy 23 from a licensed insurance carrier in this state which insures 24 the renter in the same manner and amounts of the policy obtained 25 by the livery under paragraph (a) and provides to each renter 26 the insurance carrier's name and address and the insurance 27 policy number; or 28 2. Presents the renter with the opportunity to purchase 29 coverage which insures the renter against any accident, loss, 30 injury, property damage, or other casualty caused by or 31 resulting from the operation of the livery vessel of at least 32 \$500,000 per person and \$1 million per event.
