(c) Upon registration of a motorcycle, motor-driven cycle,
or moped, in addition to the license taxes specified in this
subsection, a nonrefundable motorcycle safety education fee in
the amount of \$2.50 shall be paid. The proceeds of such
additional fee shall be deposited in the Highway Safety
Operating Trust Fund to fund a motorcycle driver improvement
program implemented pursuant to s. 322.025 $\underline{\text{or}}_{\mathcal{T}}$ the Florida
Motorcycle Safety Education Program established in s. 322.0255 $_{ au}$
or the general operations of the department. The department
shall submit an annual report to the President of the Senate and
the Speaker of the House of Representatives outlining the
revenues collected by the fee, funds and methods used to
