26 A conspicuous no trespassing notice is painted on 2.a. 27 trees or posts on the property, provided that the notice is: 28 (I) Painted in an international orange color and 29 displaying the stenciled words "No Trespassing" in letters no 30 less than 2 inches high and 1 inch wide either vertically or horizontally; 31 32 (II)Placed so that the bottom of the painted notice is 33 not less than 3 feet from the ground or more than 5 feet from 34 the ground; and 35 (III) Placed at locations that are readily visible to any 36 person approaching the property and no more than 500 feet apart 37 on agricultural land. When a landowner uses the painted no trespassing 38 b. 39 posting to identify a no trespassing "no trespassing" area, those painted notices must shall be accompanied by signs 40 41 complying with subparagraph 1. and placed conspicuously at all places where entry to the property is normally expected or known 42 43 to occur. 44 Section 2. This act shall take effect July 1, 2023.
