20.316 Department of Juvenile Justice.—There is created a Department of Juvenile Justice.

(1) SECRETARY OF JUVENILE JUSTICE. -

- (c) The Secretary of Juvenile Justice shall:
- 1. Ensure that juvenile justice continuum programs and services are implemented according to legislative intent; state and federal laws, rules, and regulations; statewide program standards; and performance objectives by reviewing and monitoring regional and circuit program operations and providing technical assistance to those programs.
- 2. Identify the need for and recommend the funding and implementation of an appropriate mix of programs and services within the juvenile justice continuum, including prevention, diversion, nonresidential and residential commitment programs, training schools, and conditional release programs and services, with an overlay of educational, career and technical education vocational, alcohol, drug abuse, and mental health services where appropriate.
- 3. Oversee the establishment of the Florida Scholars

- 7.6. Establish program policies and rules and ensure that those policies and rules encourage cooperation, collaboration, and information sharing with community partners in the juvenile justice system to the extent authorized by law.
  - 8.7. Develop funding sources external to state government.

Section 2. Section 985.619, Florida Statutes, is created to read:

## 985.619 Florida Scholars Academy.-

- (1) (a) The department shall establish the Florida Scholars

  Academy within the department to deliver educational

  opportunities for students serving in residential commitment

  programs under this chapter.
- (b) Each residential program site established, authorized, or designated by the department shall be considered a campus of the Florida Scholars Academy.
- (c) Students sentenced to adult facilities under chapter 944 are not eligible to enroll in the Florida Scholars Academy.
- (2) The mission of the academy is to provide a free and appropriate high-quality education for eligible students within the juvenile justice system and to prepare students for gainful employment as productive citizens upon their reentry into the community. Educational pathways will include a K-12 education, a high school equivalency diploma, a career and technical education credential pursuant to s. 1003.4282(10), and enrollment in a degree program at a state college or university, with an emphasis on attaining an industry-recognized credential of value from the Master Credentials List under s.

- (3) (a) The department shall enter into a contractual agreement with an education service provider with a proven track record of success to operate, provide, or supplement full-time instruction and instructional support services for students to earn a high school diploma or high school equivalency diploma, enroll in a degree program at a state college or university, and earn industry-recognized credentials of value from the Master Credentials List. The contracted education service provider shall be responsible for the administration of all educational services to students enrolled in the academy.
- (b) The secretary shall appoint the superintendent of the Florida Scholars Academy. The superintendent shall be responsible for the management and day-to-day operation of the Florida Scholars Academy.
- (4)(a) The Florida Scholars Academy shall be governed by a board of trustees. Board members shall serve a term of 4 years.

  The board shall be composed of five members:
  - 1. The secretary of the department or his or her designee.
  - 2. The superintendent of the Florida Scholars Academy.
  - 3. Three members appointed by the governor.
- (b) The board of trustees shall have the following powers and duties:
- 1. To meet at least 4 times each year, upon the call of the chair, or at the request of a majority of the membership.

2. To be responsible for the development of an education delivery system by the Florida Scholars Academy's development that is cost-effective, high-quality, educationally sound, and sustainable.

- 3. To identify appropriate performance measures and standards based on student achievement that reflect the Florida Scholars Academy's statutory mission and priorities, and to implement an accountability system approved by the State Board of Education for the Florida Scholars Academy by the 2024-2025 school year that includes an assessment of the academy's effectiveness and efficiency in providing quality services that encourage high student achievement, seamless articulation, and maximum access to career opportunities. For the 2024-2025 school year, the results of the accountability system shall serve as an informative baseline for the academy to work toward improved performance in future years.
- 4. To administer and maintain the educational programs of the Florida Scholars Academy in accordance with law and with the rules established by the department, in consultation with the State Board of Education.
- 5. To determine, with the approval of the secretary or his or her designee, the compensation, including salaries and fringe benefits, and other conditions of employment for academy personnel, in alignment with the Florida Scholars Academy's provider contracts.

7. To provide for the content and custody of student records pursuant to s. 1002.22.

- 8. To maintain the financial records and accounts of the Florida Scholars Academy, which shall be maintained under rules adopted by the State Board of Education for the uniform system of financial records and accounts for the schools of the state.
- 9. To select a chair. Initially, the secretary or his or her designee shall serve as chair.
- (c) Members of the board of trustees shall serve without compensation but may be reimbursed for per diem and travel expenses pursuant to s. 112.061.
- (d) The board of trustees shall be a body corporate with all the powers of a body corporate and such authority as is needed for the proper operation and improvement of the Florida Scholars Academy. The board of trustees may adopt rules, policies, and procedures, consistent with law and the rules of the State Board of Education relating to governance, personnel, budget and finance, administration, programs, curriculum and instruction, travel and purchasing, technology, students, contracts and grants, and property as necessary for the optimal

(1) The Department of Juvenile Justice shall provide early notice to school districts regarding the siting of new juvenile justice <u>detention</u> facilities. School districts shall include the projected number of students in the districts' annual estimates. School districts must be consulted regarding the types of students expected to be assigned to <u>detention</u> commitment facilities for education planning and budgeting purposes.

- (2) The Department of Juvenile Justice shall notify, in writing, the Department of Education when a request for proposals is issued for the construction or operation of a commitment or detention facility anywhere in the state. The Department of Juvenile Justice shall notify, in writing, the appropriate school district when a request for proposals is issued for the construction or operation of a commitment or detention facility when a county or site is specifically identified.
- (3) The Department of Juvenile Justice shall also notify the district school superintendent within 30 days after:
