#### SUMMARY ANALYSIS

The Florida Constitution requires the state to be divided into counties and recognizes two types of county governments: those operating under a county charter and those without a charter. Non-charter county governments have the power of self-government as is provided by general or special law. However, an ordinance in conflict with a municipal ordinance shall not be effective within the municipality to the extent of such conflict.

Manatee County is located on the Florida Gulf Coast and is home to Anna Maria Island. Within Anna Maria Island are three municipalities: Anna Maria, Bradenton Beach, and Holmes Beach. There are tensions between the City of Holmes Beach and Manatee County revolving around public parking and the potential need for a parking garage within Holmes Beach. Holmes Beach has recently passed an ordinance prohibiting multi-level parking facilities within the boundaries of the city.

The bill authorizes Manatee County to construct one parking facility within the City of Holmes Beach. The bill provides specifications for certain aspects of the parking garage and allows the county to issue necessary permit for its construction.

The Economic Impact Statement (EIS) filled with the bill states that the estimated cost for the parking garage will be \$45 million for the construction of the parking garage in the first fiscal year and \$400,000 in the second fiscal year for annual maintenance.

### **FULL ANALYSIS**

### I. SUBSTANTIVE ANALYSIS

## A. EFFECT OF PROPOSED CHANGES:

### **Present Situation**

## Non-Charter Counties

The Florida Constitution requires the Legislature to divide the state into counties. The Florida Constitution recognizes two types of county governments: those operating under a county charter and those without a charter.<sup>2</sup> Non-charter county governments have the power of self-government as is provided by general or special law.<sup>3</sup> The board of county commissioners of a non-charter county may enact, in a manner prescribed by general law, county ordinances not inconsistent with general or special law. However, a county ordinance in conflict with a municipal ordinance shall not be effective within the municipality to the extent of such conflict.4 Manatee County is a non-charter county.5

# Anna Maria Island Parking Issues

Anna Maria Island is an island located within Manatee County that is home to three municipalities: Anna Maria, Bradenton Beach, and Holmes Beach.<sup>6</sup> Recent years have seen tensions between the city of Holmes Beach and the county revolving around parking availability on Anna Maria Island, specifically the Holmes Beach portion of the island. The main issue revolves around the county-owned Manatee Public Beach. County officials claim that there is insufficient available parking in Holmes Beach to accommodate tourists and nonresident travel to the island and Manatee Public Beach. County officials estimate that available public parking spaces has decreased from 2,400 parking spaces before the pandemic to 1,260 available public parking spaces today. Of the reduced spaces, 640 have been converted from spaces available to the general public to ones that require a permit. The overall reduction was due to various reclassifications of neighborhood parking and the elimination of street spaces.

In April 2022, discussions were held between the City of Holmes Beach, Manatee County officials, and members of the Manatee County state legislative delegation with the hope of resolving the issue.<sup>8</sup> A few weeks after the meeting, the City of Holmes Beach passed an ordinance restricting multi-level parking facilities within the city.9

## **Effect of Proposed Changes**

The bill authorizes Manatee County, notwithstanding any law, local ordinance, or local regulation, to construct a parking facility within the City of Holmes Beach, without obtaining any permit, approval, consent, or letter of no objection from the City of Holmes Beach. The bill allows the County to issue a permit for construction of a parking facility. The parking facility may not exceed 36 feet, except for elevator shafts, flag poles, heating and air conditioning, solar collectors, and other similar equipment. The bill requires any rooftop features of the garage to cover no more than one-third of the garage's total

area and to set back one foot from the edge of the foot for every foot the feature extends above the roof's surface.

The parking facility must be located in a public park managed by the county. The facility may also include certain amenities, including public sanitary facilities, retail and dining establishments, and other recreational and entertainment amenities. The bill allows the county to issue permits for the construction of the parking facility and any other structure build pursuant to the provisions of the bill.

The Economic Impact Statement (EIS) filled with the bill states that the estimated cost for the parking garage will be \$45 million for the construction of the parking garage in the first fiscal year and \$400,000 in the second fiscal year for annual maintenance. The estimate cost for construction is based on a minimum of 1500 parking spots at \$30,000 per spot.
