GENERAL PROVISIONS

SECTION 2. Seat of government.—The seat of government shall be the City of Tallahassee, in Leon County, where the offices of the governor, ~~lieutenant governor~~, cabinet members, and the supreme court shall be maintained and the sessions of the legislature shall be held; provided that, in time of invasion or grave emergency, the governor by proclamation may for the period of the emergency transfer the seat of government to another place.

(b) The person elected to the office of lieutenant governor in the 2026 general election shall assume the office of the commissioner of government efficiency for a term of four years, and the years of such term shall be counted toward the number of consecutive years in Section 4(c) of Article VI. Beginning with the 2030 general election, the office of the commissioner of government efficiency shall be filled by election pursuant to Section 5(a) of Article IV.
