(1) Each member of the board of county commissioners of a noncharter county shall receive as salary the amount indicated, based on the population of his or her county. In addition, compensation shall be made for population increments over the minimum for each population group, which shall be determined by multiplying the population in excess of the minimum for the grouping times the group rate.

46 special law, general law of local application, resolution, or
47 supplement or from any other source is a misdemeanor of the
48 first degree punishable as provided in ss. 775.082 and 775.083.
