An act relating to the City of Coral Springs and the City of Parkland, Broward County; reducing and contracting from the corporate limits of the City of Coral Springs and enlarging and extending the corporate limits of the City of Parkland approximately 8.7 acres of land contiguous to the corporate limits of the City of Parkland; providing boundaries; providing construction; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The present corporate limits of the City of Coral Springs, Broward County, Florida, are hereby reduced and contracted so as to exclude, from the territory presently within the City of Coral Springs corporate limits, and the present corporate limits of the City of Parkland, Broward County, are hereby enlarged and extended so as to include, effective September 15, 2025, in addition to the territory presently within the City of Parkland corporate limits, an approximately 8.494 acre parcel of land, contiguous to the corporate limits of the City of Parkland, particularly described as follows:
