7 (1) That portion of S.R. 295/Navy Boulevard between Duncan

8 Road and S.R. 292/Gulf Beach Highway in Escambia County is

9 designated as "Warrior Sacrifice Way."

10 (2) That portion of U.S. 90 in Baker County between N. 3rd

11 Street and the Nassau County line is designated as "State

12 Representative/Circuit Judge Hon. John J. Crews, Jr., Memorial

13 Highway."

14 (3) The bridge on Moncrief Road West over the Ribault
15 River in Duval County is designated as "Bernard Wilkes Ribault
16 River Bridge."

17 (4) That portion of U.S. 41 between North Creek and
18 Blackburn Point Road in Sarasota County is designated as "Dickey
19 Betts Memorial Highway."

20 (5) That portion of S.R. 5/U.S. 1 between N.E. 38th Street
21 and E. Commercial Boulevard in Broward County is designated as
22 "Phil Smith Memorial Highway."

23 (6) That portion of S.R. 46 between Sanford Avenue and E.
24 Lake Mary Boulevard in Seminole County is designated as "Mayor
25 Larry A. Dale Memorial Highway."

26 (7) The northbound off-ramp from U.S. 1 Alternate/Martin
27 Luther King, Jr., Parkway to E. 21st Street in Duval County is
28 designated as "Terry L. Fields Memorial Access."

29 (8) Notwithstanding s. 334.071(3), Florida Statutes, the
30 entirety of S.R. 80, consisting of the 124 contiguous miles of
31 highway stretching from S.R. A1A/S. Ocean Boulevard in Palm
32 Beach County, continuing westward through Hendry County, and
33 ending at a junction with U.S. 41/Cleveland Avenue in Lee
34 County, is designated as "President Donald J. Trump Highway."
35 This designation shall replace and expand the designation
36 adopted in ch. 2025-214, Laws of Florida, for that portion of
37 Southern Boulevard between Kirk Road and S. Ocean Boulevard in
38 Palm Beach County.
