A bill to be entitled
An act relating to public records; amending s.
119.071, F.S.; defining terms; providing an exemption
from public records requirements for the personal
identifying and location information of current and
former owners and operators of family foster homes and
the names and personal identifying and location
information of the spouses and children of such owners
and operators; providing for future legislative review
and repeal of the exemption; providing for retroactive
application of the exemption; providing a statement of
public necessity; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraph (d) of subsection (4) of section
119.071, Florida Statutes, is amended to read:

119.071 General exemptions from inspection or copying of
public records.—

(4) AGENCY PERSONNEL INFORMATION.—

(d)1. For purposes of this paragraph, the term:

a. "Home addresses" means the dwelling location at which an
individual resides and includes the physical address, mailing
address, street address, parcel identification number, plot
identification number, legal property description, neighborhood
name and lot number, GPS coordinates, and any other descriptive
property information that may reveal the home address.

b. "Judicial assistant" means a court employee assigned to
the following class codes: 8140, 8150, 8310, and 8320.

30 c. "Telephone numbers" includes home telephone numbers,
31 personal cellular telephone numbers, personal pager telephone
32 numbers, and telephone numbers associated with personal
33 communications devices.

34 2.a. The home addresses, telephone numbers, dates of birth,
35 and photographs of active or former sworn law enforcement
36 personnel or of active or former civilian personnel employed by
37 a law enforcement agency, including correctional and
38 correctional probation officers, personnel of the Department of
39 Children and Families whose duties include the investigation of
40 abuse, neglect, exploitation, fraud, theft, or other criminal
41 activities, personnel of the Department of Health whose duties
42 are to support the investigation of child abuse or neglect, and

I of the State Constitution.

d. The home addresses, telephone numbers, dates of birth, and photographs of current or former firefighters certified in compliance with s. 633.408; the names, home addresses, telephone numbers, photographs, dates of birth, and places of employment of the spouses and children of such firefighters; and the names and locations of schools and day care facilities attended by the children of such firefighters are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.

e. The home addresses, dates of birth, and telephone numbers of current or former justices of the Supreme Court, district court of appeal judges, circuit court judges, and county court judges and current judicial assistants; the names, home addresses, telephone numbers, dates of birth, and places of

I of the State Constitution.

k. I of the State Constitution.

s. The home addresses, telephone numbers, dates of birth, and photographs of current or former directors, managers, supervisors, nurses, and clinical employees of an addiction treatment facility; the home addresses, telephone numbers, photographs, dates of birth, and places of employment of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution. For purposes of this sub-subparagraph, the term "addiction treatment facility" means a county government, or agency thereof, that is licensed pursuant to s. 397.401 and provides substance abuse prevention, intervention, or clinical treatment, including any licensed

t. The home addresses, telephone numbers, dates of birth, and photographs of current or former directors, managers, supervisors, and clinical employees of a child advocacy center that meets the standards of s. 39.3035(2) and fulfills the screening requirement of s. 39.3035(3), and the members of a Child Protection Team as described in s. 39.303 whose duties include supporting the investigation of child abuse or sexual abuse, child abandonment, child neglect, and child exploitation or to provide services as part of a multidisciplinary case review team; the names, home addresses, telephone numbers, photographs, dates of birth, and places of employment of the spouses and children of such personnel and members; and the names and locations of schools and day care facilities attended by the children of such personnel and members are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.

u. The home addresses, telephone numbers, places of employment, dates of birth, and photographs of current or former staff and domestic violence advocates, as defined in s. 90.5036(1)(b), of domestic violence centers certified by the Department of Children and Families under chapter 39; the names, home addresses, telephone numbers, places of employment, dates of birth, and photographs of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution. This sub-subparagraph is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2029, unless reviewed and saved from repeal through reenactment by the Legislature.

y. (A) "Child" or "children" means an unmarried person under the age of 18 who has not been emancipated by order of the court and who is related to an owner or operator either by blood, marriage, or adoption or who has been placed in a family foster home by the Department of Children and Families.

(B) "Family foster home" has the same meaning as in s. 409.175(2).

(C) "Operator" has the same meaning as in s. 409.175(2).

(D) "Owner" has the same meaning as in s. 409.175(2).

(II) The home addresses, telephone numbers, places of employment, dates of birth, and photographs of current or former owners and operators of family foster homes; the names, home addresses, telephone numbers, dates of birth, and places of employment of the spouses and children of such persons; and the names and locations of schools and day care facilities attended by the children of such persons are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.

aa.(I) As used in this sub-subparagraph, the term:

(A) "Congressional member" means a person who is elected to serve as a member of the United States House of Representatives or is elected or appointed to serve as a member of the United States Senate.

(B) "Partial home address" means the dwelling location at which an individual resides and includes the physical address, mailing address, street address, parcel identification number, plot identification number, legal property description, neighborhood name and lot number, GPS coordinates, and any other descriptive property information that may reveal the partial home address, except for the city and zip code.

(C) "Public officer" means a person who holds one of the following offices: Governor, Lieutenant Governor, Chief Financial Officer, Attorney General, Agriculture Commissioner, state representative, state senator, property appraiser, supervisor of elections, school superintendent, school board member, mayor, city commissioner, or county commissioner.

(II) The following information is exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution:

(A) The partial home addresses of a current congressional member or public officer and his or her spouse or adult child.

(B) The telephone numbers of a current congressional member or public officer and his or her spouse or adult child.

(C) The name, home addresses, telephone numbers, and date of birth of a minor child of a current congressional member or public officer and the name and location of the school or day care facility attended by the minor child.

(III) This sub-subparagraph is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2030, unless reviewed and saved from repeal through reenactment by the Legislature.

3.a. An agency that is the custodian of the information specified in subparagraph 2. and that is not the employer of the

officer, employee, justice, judge, or other person specified in subparagraph 2. must maintain the exempt status of that information only if the officer, employee, justice, judge, other person, or employing agency of the designated employee submits a written and notarized request for maintenance of the exemption to the custodial agency. The request must state under oath the statutory basis for the individual's exemption request and confirm the individual's status as a party eligible for exempt status.

b. An agency that is the custodian of information specified in sub-subparagraph 2.aa. ~~2.z.~~ and that is not the employer of the congressional member, public officer, or other person specified in sub-subparagraph 2.aa. ~~2.z.~~ must maintain the exempt status of that information only if an individual requests the maintenance of an exemption pursuant to sub-subparagraph 2.aa. ~~2.z.~~ on the basis of eligibility as a current congressional member or public officer and his or her spouse or child submits, as part of the written and notarized request required by sub-subparagraph a., the date of the congressional member's or public officer's election or appointment to public office, the date on which that office is next subject to election, and, if applicable, the date on which the current congressional member's or public officer's minor child reaches the age of majority. The custodian must maintain an exemption granted pursuant to sub-subparagraph 2.aa. ~~2.z.~~ until the qualifying conditions for the exemption no longer apply to the person subject to the exemption.

4.a. A county property appraiser, as defined in s. 192.001(3), or a county tax collector, as defined in s.

192.001(4), who receives a written and notarized request for maintenance of the exemption pursuant to subparagraph 3. must comply by removing the name of the individual with exempt status and the instrument number or Official Records book and page number identifying the property with the exempt status from all publicly available records maintained by the property appraiser or tax collector. For written requests received on or before July 1, 2021, a county property appraiser or county tax collector must comply with this sub-subparagraph by October 1, 2021. A county property appraiser or county tax collector may not remove the street address, legal description, or other information identifying real property within the agency's records so long as a name or personal information otherwise exempt from inspection and copying pursuant to this section is not associated with the property or otherwise displayed in the public records of the agency.

b. Any information restricted from public display, inspection, or copying under sub-subparagraph a. must be provided to the individual whose information was removed.

5. An officer, an employee, a justice, a judge, or other person specified in subparagraph 2. may submit a written request for the release of his or her exempt information to the custodial agency. The written request must be notarized and must specify the information to be released and the party authorized to receive the information. Upon receipt of the written request, the custodial agency must release the specified information to the party authorized to receive such information.

6. The exemptions in this paragraph apply to information held by an agency before, on, or after the effective date of the

466 7. Information made exempt under this paragraph may be
467 disclosed pursuant to s. 28.2221 to a title insurer authorized
468 pursuant to s. 624.401 and its affiliates as defined in s.
469 624.10; a title insurance agent or title insurance agency as
470 defined in s. 626.841(1) or (2), respectively; or an attorney
471 duly admitted to practice law in this state and in good standing
472 with The Florida Bar.

473 8. The exempt status of a home address contained in the
474 Official Records is maintained only during the period when a
475 protected party resides at the dwelling location. Upon
476 conveyance of real property after October 1, 2021, and when such
477 real property no longer constitutes a protected party's home
478 address as defined in sub-subparagraph 1.a., the protected party
479 must submit a written request to release the removed information
480 to the county recorder. The written request to release the
481 removed information must be notarized, must confirm that a
482 protected party's request for release is pursuant to a
483 conveyance of his or her dwelling location, and must specify the
484 Official Records book and page, instrument number, or clerk's
485 file number for each document containing the information to be
486 released.

487 9. Upon the death of a protected party as verified by a
488 certified copy of a death certificate or court order, any party
489 can request the county recorder to release a protected
490 decedent's removed information unless there is a related request
491 on file with the county recorder for continued removal of the
492 decedent's information or unless such removal is otherwise
493 prohibited by statute or by court order. The written request to

495 party must attach the certified copy of a death certificate or

500 information to be released. A fee may not be charged for the
501 release of any document pursuant to such request.

502 Section 2. (1) The Legislature finds that it is a public
503 necessity that the home addresses, telephone numbers, places of
504 employment, dates of birth, and photographs of former and
505 current owners and operators, and their spouses and children, of
506 family foster homes licensed by the Department of Children and
507 Families, and the names and locations of schools and day care
508 facilities attended by the children of such persons be made
509 exempt from s. 119.07(1), Florida Statutes, and s. 24(a),
510 Article I of the State Constitution. Such identifying and
511 location information can be used to locate children placed in a
512 family foster home by the Department of Children and Families,
513 the owner or operator of such home, and the other children
514 living at the home to threaten or harm the children, owner, or
515 operator; to perpetuate fraud against any of these individuals;
516 or to acquire sensitive personal, financial, medical, and
517 familial information, the release of which could cause great
518 financial harm to the individual.

519 (2) Children placed in a family foster home are often
520 removed from the care of their biological parents due to
521 physical, sexual, and emotional abuse; domestic violence; drug
522 use; neglect; and many other reasons for which the state has

523 identified the children are in danger. As such, it is necessary
524 to protect the location of such children from being known by
525 their biological parents until the case has been litigated and
526 the children have been returned to their biological parents upon
527 satisfactory completion of their case plan and having their
528 parenting rights restored. As a result of being the person
529 ultimately responsible for the care of a child who is removed
530 from the home of his or her biological parents, owners and
531 operators of family foster homes may incur the ill will of the
532 biological parents, thus making such owners and operators and
533 their other children targets for acts of revenge. If such
534 identifying and location information is released, the safety of
535 the owners and operators of family foster homes and all children
536 living with them could be seriously jeopardized. The Legislature
537 further finds that the harm that may result from the release of
538 such personal identifying and location information outweighs any
539 public benefit that may be derived from the disclosure of the
540 information.

541 Section 3. This act shall take effect July 1, 2026.
