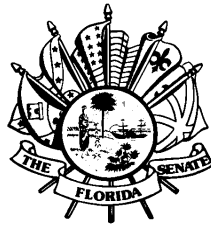

BILLS ON THIRD READING

CS/SB 804 (3R) by the Committee on Judiciary and Senator Webster—

Artificially Provided Sustenance; prohibits suspension of sustenance or hydration under certain conditions; authorizes certain parties to petition court to prevent suspension of sustenance or hydration; specifies that act is remedial & provides for its application. Creates 765.405. Effective Date: Upon becoming law.

Read the second time on March 17, 2005, and read the third time on March 18, 2005

*Compare to **HB 701 (HC)** in Messages*

SB 908 (3R) by Senator Constantine—

Wekiva Parkway & Protection Act; clarifies DEP's rulemaking authority to implement certain recommendations; clarifies that requirements for local government to develop master stormwater management plan & wastewater facility plan apply only to that portion of local govt. located within Wekiva Study Area; requires local governments hosting interchange on said parkway to adopt interchange land use plan within 1 year after interchange location is established, etc. Amends Ch. 369. Effective Date: Upon becoming law.

Read the second time and amended on March 22, 2005

SB 724 (3R) by Senator Margolis and others—

Affordable Housing/Elderly; increases cap on certain loan amounts available to sponsors of housing for elderly. Amends 420.5087. Effective Date: 07/01/2005.

Read the second time on March 22, 2005

CS/SB 512 (3R) by the Committee on Children and Families, Senator Aronberg and others—

Protective Injunctions; provides standing for governmental employer to seek injunction for protection against repeat violence on behalf of employee; revises application of evidentiary requirements re injunctions for protection of minor children. Amends 784.046. Effective Date: Upon becoming law.

Read the second time on March 22, 2005

CS/CS/SB 436 (3R) by the Committees on Judiciary, Criminal Justice, Senator Peadar and others—

Protection of Persons/Use of Force; authorizes person to use force, including deadly force, against intruder or attacker in dwelling, residence, or vehicle under specified circumstances; provides that person is justified in using deadly force under certain circumstances; provides immunity from criminal prosecution or civil action for using deadly force; defines term "criminal prosecution", etc. Creates 776.013,.032; amends 776.012,.031. Effective Date: 10/01/2005.

Read the second time and amended on March 22, 2005

SB 532 (3R) by Senator Campbell—

Court Orders/Payment Awards; authorizes certain court orders to include additional reasonable amounts for certain attorney's fees, suit money, & costs related to certain proceedings. Amends 61.16, 742.045. Effective Date: Upon becoming law.

Read the second time on March 22, 2005

CS/SB 1012 (3R) by the Committee on Regulated Industries and Senator Argenziano—

Professions Regulated by DBPR; provides for reinstatement of certain voided licenses; provides requirements for application & reinstatement of voided licenses, including fees, continuing education, & eligibility; provides exemption. Amends 455.271. Effective Date: 07/01/2005.

Read the second time on March 22, 2005

SB 730 (3R) by Senator Fasano—

Lewdness; redefines term "lewdness" for purposes of provisions prohibiting & providing penalties for prostitution, lewdness, or assignation. Amends 796.07. Effective Date: 07/01/2005.

Read the second time and amended on March 22, 2005

SB 52 (3R) by Senator Geller—

Commercial Motor Vehicles; provides definitions; requires minimum amount of insurance coverage for persons engaged in retrofitting, rebuilding, or modifying commercial trucks, truck tractors, or heavy trucks into dump trucks; provides safety standards; provides penalties. Creates 316.570. Effective Date: 10/01/2005.

Read the second time and amended on March 22, 2005

SB 310 (3R) by Senator Fasano—

Bingo Games; authorizes use of electronics or other technology in lieu of vocal verification for bingo games; revises definition of "organization" to include chambers of commerce; exempts chambers of commerce from provisions prohibiting drawings by chance. Amends 849.0931, .0935. Effective Date: 07/01/2005.

Read the second time and amended on March 22, 2005

CS/SB 1368 (3R) by the Committee on Judiciary and Senator Aronberg—

Disclaimer of Property Interests Act; cites act as Fla. Uniform Disclaimer of Property Interests Act; prescribes general provisions re persons' powers to disclaim interest in or power over property; prescribes rules applicable to disclaimer of interest in property & interests in property held as tenancy by entirety; prescribes effect of tax-qualified disclaimer, etc. Creates 739.101-.701; amends 731.201, 121.091, 710.121; repeals 689.21, 732.801. Effective Date: 07/01/2005.

FAMU Day/March 23, 2005; recognizes March 23, 2005, as "FAMU Day" in Tallahassee, in recognition of Florida Agricultural & Mechanical University's contributions as outstanding institution of higher education.

SR 2690 (SR) by Senator Wise and others—

Fowler, Congresswoman Tillie Kidd; pays tribute to memory of outstanding Floridian & American, Congresswoman Tillie Kidd Fowler, & extends condolences to her family & to her husband Buck Fowler & her daughters Tillie Anne & Elizabeth Fowler.

**SENATE BILLS ON
SECOND READING**

SB 90 (2R) by Senator Lawson and others—

Herbert F. Morgan Building; designates FAMU-FSU College of Engineering Building as "Herbert F. Morgan Building"; provides for erection of markers. Effective Date: Upon becoming law.

Reported favorably by the Committees on Education and Governmental Oversight and Productivity

SB 116 (2R) by Senator Saunders and others—

Culpable Negligence/Vehicles/DUI; provides that it is first-degree misdemeanor for person to commit culpable negligence by driving vehicle under influence of alcohol or drugs while accompanied in vehicle by person younger than specified age. Amends 784.05. Effective Date: 07/01/2005.

Reported favorably by the Committees on Criminal Justice and Judiciary

CS/SB 122 (2R) by the Committee on Criminal Justice, Senator Saunders and others—

Homestead Exemption/Fraudulent Act; provides value-based sliding scale of criminal penalties applicable to claimant who knowingly & willfully gives false information for purpose of claiming homestead exemption if funds for homestead were obtained by commission of fraudulent act. Amends 196.131. Effective Date: 10/01/2005.

Reported favorably as a committee substitute by the Committee on Criminal Justice

CS/SB 152 (2R) by the Committee on Judiciary and Senator Siplin—

Alimony; authorizes court to modify payment of alimony if there is proof by preponderance of evidence that recipient former spouse is in de facto marriage with person of opposite sex outside of legal bond of matrimony; prescribes factors to be considered by court; provides for application. Amends 61.14. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Judiciary

CS/SB 232 (2R) by the Committee on Domestic Security and Senator Constantine—

Emergency Management; provides that it is policy of Legislature to encourage counties & municipalities to explore use of emerging technologies for purpose of disseminating information to public before, during, & after emergency or natural disaster; authorizes county or municipality to establish volunteer disaster assistance recovery program, etc. Amends 252.32,.38. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Domestic Security and the Committee on Community Affairs reports the committee substitute favorably

SB 268 (2R) by Senator Posey—

Elections/Early Voting; changes day on which early voting ends. Amends 101.657. Effective Date: Upon becoming law.

Reported favorably, with one amendment, by the Committee on Ethics and Elections

SB 312 (2R) by Senator Fasano—

Prisoners/Sale of Literary Accounts; defines terms concerning sale of literary accounts & memorabilia by & on behalf of convicted felon; provides for lien in favor of state on proceeds or profits of sale of literary accounts, materials, & memorabilia payable to or accruing to convicted felon, representative of convicted felon, or profiteer of felony; provides for distribution of proceeds or profits of sale of literary accounts or memorabilia, etc. Amends 944.512, 960.291. Effective Date: 07/01/2005.

Reported favorably, with two amendments, by the Committee on Judiciary and reported favorably by the Committee on Criminal Justice

SB 450 (2R) by Senator Geller—

Motor Vehicle Ins. Increase/Military; provides that certain rate increases for motor vehicle insurance for insureds on active military service constitute unfair practices; provides penalties. Amends 626.9541. Effective Date: Upon becoming law.

Reported favorably, with one amendment, by the Committee on Banking and Insurance, and reported favorably by the Committee on Community Affairs

SB 554 (2R) by Senator Haridopolos and others—

Property Taxes; authorizes counties to cap annual growth in ad valorem tax revenues by charter; provides requirements & limitations; provides exception; prohibits ad valorem tax levies by counties in excess of amounts specified in county charter; prohibits ad valorem tax levies by counties through municipal service taxing units in excess of amounts specified in ordinance establishing unit. Amends 200.071. Effective Date: 01/01/2006.

Reported favorably, with one amendment, by the Committee on Community Affairs and reported favorably, with three amendments, by the Committee on Government Efficiency Appropriations

SB 574 (2R) by Senator Haridopolos and others—

Official Fruit of Florida; designates orange as official fruit of State of Florida. Creates 15.0315. Effective Date: Upon becoming law.

Reported favorably by the Committees on Agriculture and Governmental Oversight and Productivity

CS/SB 690 (2R) by the Committee on Health Care and Senator Lynn—

Immunizations/Mercury Contents; prohibits vaccinating woman who is knowingly pregnant or child who is younger than specified age with vaccine that contains any mercury or injecting such woman or child with product that contains more than specified amount of mercury; provides for State Health Officer to authorize use of vaccines that contain greater amount of mercury than is otherwise allowed if Health Secretary declares public health emergency & makes certain findings, etc. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Health Care

CS/SB 832 (2R) by the Committee on Agriculture, Senator Smith and others—

Obsolete Agricultural Equipment; provides for obsolete agricultural equipment to be assessed at its value as salvage; defines term "agricultural equipment"; provides procedure for taxpayer to claim right of assessment under this section; authorizes property appraiser to require information establishing taxpayer's right to classification. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Agriculture and the Committee on Government Efficiency Appropriations reports the committee substitute favorably, with one amendment

SB 878 (2R) by Senator Baker—

Delinquent Property Taxes; reduces number of required advertisements for certain tax certificate sales; specifies minimum time period for such advertisement prior to sale; revises requirement for transmitting copy of published notice. Amends 197.402,.403. Effective Date: Upon becoming law.

Reported favorably by the Committee on Community Affairs and reported favorably, with one amendment, by the Committee on Government Efficiency Appropriations

SB 904 (2R) by Senator Dockery—

Privatization of Foster Care; provides that lead community-based provider & its subcontractors supplying foster care & related services are exempt from including in written contracts & other written documents certain statements required by law; provides exception if said provider or its subcontractors receive more than 51 percent of their total funding from state. Amends 409.1671. Effective Date: Upon becoming law.

Reported favorably by the Committee on Children and Families, and reported favorably, with one amendment, by the Committee on Governmental Oversight and Productivity

SB 1020 (2R) by Senator Haridopolos and others—

Police, Fire, SAR Dogs/Police Horses; prohibits intentionally & knowingly causing great bodily harm to or using deadly weapon upon said animals; prohibits actually & intentionally maliciously touching, striking, or causing bodily harm to said animals; prohibits maliciously harassing, teasing, interfering with, or attempting to interfere with said animals while animal is in performance of its duties; provides for restitution from violators, etc. Amends 843.19. Effective Date: 07/01/2005.

Reported favorably, with two amendments, by the Committee on Criminal Justice

FIRST PUBLICATION ON SECOND READING

SB 356 (2R) by Senator Lynn—

Substance Abuse Treatment; includes intensive inpatient treatment within service components provided by licensed service provider; reenacts specified provision re treatment providers, to incorporate amendment to certain provision, in references thereto; amends provisions re treatment services & drug-free workplace program to conform cross-references, etc. Amends 397.311, 212.055, 397.416, 440.102; reenacts 397.405(8), 397.407(1). Effective Date: 07/01/2005.

Reported favorably by the Committees on Children and Families, and Health Care and withdrawn from the Committee on Health and Human Services Appropriations

SB 470 (2R) by Senator Argenziano and others—

Indigent Care Surtax; allows small counties having specified population to levy indigent care surtax; provides procedures; provides uses of surtax; provides maximum tax rate. Revives/Reenacts/Amends 212.055(7). Effective Date: Upon becoming law.

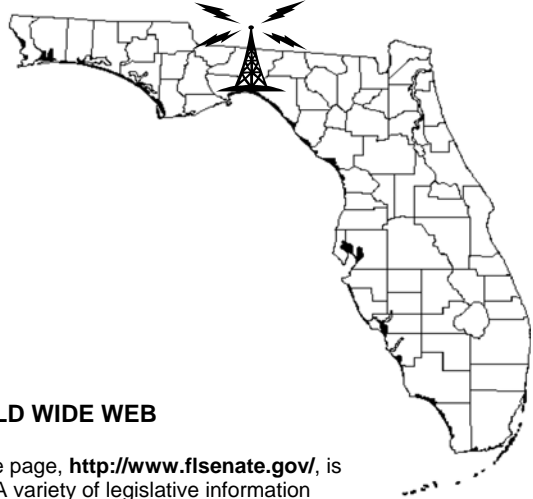
