BILLS ON THIRD READING

CS/SB 718 (3R) by the Committee on Transportation and Economic Development Appropriations and Senator Sebesta—

Transportation Department; authorizes dept. to adopt rules governing leasing of property for joint public-private development; grants local governments authority to issue permits allowing limited temporary use of state transportation right-of-way; establishes maximum limit on state-funded infrastructure bank loans to State Transportation TF; revises requirements for projects intended to mitigate adverse effects of transportation projects; etc. Amends Chs. 337, 339, 373. Effective Date: 07/01/2005.

Read the second time on April 20, 2005

HB 1659 (3R) by Representative Kottkamp and others—

Termination of Minor's Pregnancy; provides that actual notice shall be given by physician who will perform termination of pregnancy procedure; specifies information required to be included in notices; provides circumstances in which prior notice is not required; provides that violation of notice requirements by physicians shall be considered medical malpractice; requires Supreme Court to ensure certain proceedings are conducted expeditiously & lawfully, etc. Amends 390.01115. Effective Date: 07/01/2005.

CS/SB 530 (3R) by the Committee on Transportation and Economic Development Appropriations, Senator Wise and others—

DUI/Ignition Interlock Device; corrects cross-reference; directs HSMV to require placement of department-approved ignition interlock device on specified vehicles operated by any person convicted of committing certain driving-under-the-influence offenses; directs dept. to require installation of ignition interlock if court fails to order mandatory placement of device or fails to order placement for applicable period, etc. Amends 322.271; creates 322.2715. Effective Date: 07/01/2005.

Read the second time on April 27, 2005

CS/SB 284 (3R) by the Committee on Judiciary, Senator Aronberg and others—

Consumer Protection; requires business persons maintaining computerized data that includes personal information to provide notice of breaches of system security under certain circumstances; revises criminal penalties re offense of fraudulently using, or possessing with intent to fraudulently use, personal identification information; provides minimum mandatory terms of imprisonment, etc. Creates 817.5681; amends 817.568. Effective Date: 07/01/2005.

Read the second time and amended on April 28, 2005

CS/SB 1344 (3R) by the Committee on Transportation and Economic Development Appropriations, Senator Sebesta and others—

Motor Vehicles; provides that unauthorized use of traffic signal preemption device is moving violation; provides clearance specifications for railroad-highway grade crossing; deletes requirement that portion of certain fees collected by tax collector be deposited in Highway Safety Operating Trust Fund; provides 4 points to be assessed against person's driver's license for violation of certain provision, etc. Amends FS. Effective Date: 07/01/2005.

Read the second time and amended on April 28, 2005

*Similar to **HB 1697 (HC)** in the Committees on Transportation, Criminal Justice, Governmental Oversight and Productivity, and Transportation and Economic Development Appropriations*

HB 853 (3R) by Representative Reagan and others—

Motor Vehicle Lease Agreements; revises retail lessor disclosure requirements; revises requirement for copies of certain documents to be provided to lessee. Amends 521.004. Effective Date: Upon becoming law.

*Substituted for **SB 1356 (SUB)** (Alexander) and read the second time on April 29, 2005*

HB 285 (3R) by Representative Hukill and others—

Right to Speedy Trial; creates time limits within which person charged with crime must be brought to trial; permits state attorneys to file demand for speedy trial; provides conditions that must be met in order to do so; requires that trial judge schedule calendar call upon filing of demand for speedy trial in order to schedule trial; prescribes conditions under which trial court may postpone trial date. Effective Date: 07/01/2005.

*Substituted for **CS/SB 214 (SUB)** (Lynn) and read the second time on April 29, 2005*

CS/SB 1498 (3R) by the Committee on Health and Human Services Appropriations and Senator Miller—

Lead Poisoning Prevention; cites act as "Lead Poisoning Prevention Screening & Education Act"; provides for establishment of statewide comprehensive educational program on lead poisoning prevention; provides for public information initiative; provides for distribution of literature about childhood lead poisoning; requires establishment of screening program for early I.D. of persons at risk of elevated levels of lead in blood; provides for reporting of cases, etc. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

CS/CS/CS/SB 2 (3R) by the Committees on Education Appropriations, Government Efficiency Appropriations, Education, Senator King and others—

Scholarship Programs; amends provision re John M. McKay Scholarships for Students with Disabilities Program; revises requirements for scholarship funding & payments; prohibits discrimination on basis of religion by private school; amends provision re Corporate Tax Credit Scholarship Program; eliminates \$5-million cap on contributions to any single eligible nonprofit scholarship-funding organization, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 29, 2005

CS/SB 282 (3R) by the Committee on Domestic Security, Senator Aronberg and others—

Criminal Acts/State of Emergency; provides enhanced penalties for specified burglaries that are committed during state of emergency; provides that person arrested for committing burglary during state of emergency may not be released until that person appears before magistrate at first-appearance hearing; directs that felony burglary committed during state of emergency be reclassified one level above current ranking of offense committed, etc. Amends 810.02, 812.014. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/CS/SB 2236 (3R) by the Committees on Education Appropriations, Education, Senator Constantine and others—

Tuition Rates/State Universities; provides that Legislature has responsibility to establish tuition & fees; provides that tuition & fees for certain state university resident students are established within General Appropriations Act or law; requires students to pay 75 percent of actual cost per credit hour for credit hours in excess of specified number for community-college credits & for overall credits applied to baccalaureate degree, etc. Amends 1009.24; creates 1009.286. Effective Date: 07/01/2005.

Read the second time and amended on April 29, 2005

CS/CS/SB 2264 (3R) by the Committees on Education Appropriations, Education and Senator Atwater—

Students/Instructional Costs; defines term "initial enrollment" for purposes of determining postsecondary student's residential status for tuition purposes; provides that Legislature has responsibility to establish tuition & fees; requires each university to allocate certain percentage amount raised by tuition increases to financial aid for students; provides that certain students are ineligible to receive more than one state-funded tuition assistance grant, etc. Amends FS. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/SB 786 (3R) by the Committee on General Government Appropriations and Senator Clary—

Tires & Batteries/Govt. Entities/Fee; imposes fee on sale of new motor vehicle tires sold to governmental entities; imposes fee on sale of new or remanufactured lead-acid batteries sold to governmental entities; specifies that certain amendments are remedial in nature & are intended for clarification; provides that certain dealers are not eligible for refund. Amends 403.718,.7185. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/CS/SB 2542 (3R) by the Committees on Justice Appropriations, Judiciary, Senator Smith and others—

State Judicial System; revises requirements for private court-appointed counsel; requires that circuit Article V indigent services committee establish compensation rates for court-appointed counsel or in cases of indigency; provides funding for teen court through assessment of additional court cost against each person who pleads guilty or nolo contendere to, or is convicted of, violation of criminal law, ordinance, or traffic offense in county, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

HB 497 (3R) by Representative Cannon and others—

Velez Memorial Traffic Safety Act; creates Anjelica & Victoria Velez Memorial Traffic Safety Act; requires traffic citation forms to include check box indicating failure to stop at traffic signal; revises penalty for moving violation of traffic control signal steady red indication & of traffic control device when driver fails to stop at traffic signal; provides for distribution of funds to trauma centers; provides for audits & attestations, etc. Amends FS. Effective Date: 10/01/2005.

Substituted for CS/CS/SB 1264 (SUB) (Saunders) and read the second time on April 29, 2005

CS/CS/SB 1110 (3R) by the Committees on Ways and Means, Government Efficiency Appropriations and Senator Atwater—

Documentary Stamp Tax Revenue; revises monetary criteria for distributing portions of tax to certain trust funds; requires that proceeds of tax in excess of specified amounts be deposited into General Revenue Fund; revises monetary criteria for distributing portions of tax to State Housing TF & Local Government Housing TF for purposes of preserving rights of holders of affordable housing guarantees, etc. Amends 201.15. Effective Date: 07/01/2007 except as otherwise provided.

Read the second time and amended on April 29, 2005

HB 1889 (3R) by the Fiscal Council and others—

Excise Tax on Documents/Proceeds; revises monetary criteria for distributing portions of tax to certain trust funds; revises authorization for DOR to use certain amounts for certain purposes; requires that proceeds of tax in excess of specified amounts be deposited into General Revenue Fund; requires distributions to State Housing TF to be sufficient for certain purposes; provides limitation, etc. Amends 201.15. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

HB 1069 (3R) by Representative Negrón and others—

Family Readiness Program/Military; creates said program within Military Affairs Dept.; provides purpose of program; provides for program funding & use of program funds; specifies eligible services & eligible program recipients; provides procedure re requests for assistance & award of funds under program; provides for monthly audit reviews of program; provides for annual reports; provides for rulemaking authority of Military Affairs Dept. Creates 250.5206. Effective Date: 07/01/2005.

Substituted for CS/SB 1592 (SUB) (Haridopolos) and read the second time on April 29, 2005

SB 308 (3R) by Senator Fasano—

Law Officer/Investigative Interview; requires that all identifiable witnesses be interviewed, whenever possible, before beginning investigative interview of accused law enforcement officer; requires that complaint & all witness statements be given to said officer before beginning investigative interview. Amends 112.532. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/SB 1208 (3R) by the Committee on Health Care, Senator Peadar and others—

Long-term Care Partnership Program; provides conditions for eligibility; directs AHCA to establish Long-term Care Partnership Program; provides purpose & duties; directs agency to submit plan & proposed legislation to Legislature. Amends 409.905; creates 409.9102. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 29, 2005

HB 1081 (3R) by Representative Berfield and others—

Discount Medical Plan Organizations; revises provisions re licensure requirements to do business as said organization; provides requirements for issuance of license; authorizes Insurance Regulation Office to deny license; provides that said organizations are not subject to Fla. Insurance Code for purposes of examination & investigation; revises provisions re reimbursement of certain charges & fees upon cancellation of membership in plan, etc. Amends Ch. 636. Effective Date: Upon becoming law.

Substituted for CS/SB 2214 (SUB) (Saunders) and read the second time on April 29, 2005

HB 835 (3R) by Representative Detert and others—

Wind-protection/Fla. Building Code; requires Fla. Building Commission to adopt certain wind protection requirements for areas of state not within high velocity hurricane zone; provides construction; provides for incorporation into Fla. Building Code of repeal of design option re internal pressure for buildings within windborne debris region; requires commission to review damage from Hurricane Ivan & make recommendations to Legislature for changes to said code, etc. Effective Date: 07/01/2005.

*Substituted for **CS/1232 (SUB)** (Lynn), read the second time and amended on April 29, 2005*

CS/SB 1702 (3R) by the Committee on Justice Appropriations, Senator Bennett and others—

Teen Courts; authorizes board of county commissioners to adopt ordinance that incorporates provisions of act; provides funding for teen court through assessment of additional court cost against each person who pleads guilty or nolo contendere to, or is convicted of, violation of criminal law, ordinance, or traffic offense in county; requires teen court to account for all funds deposited into teen court account, etc. Amends 938.19, 939.185. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/CS/SB 428 (3R) by the Committees on Health and Human Services Appropriations, Health Care and Senator Rich—

Developmental Disabilities; requires AHCA to develop model waiver program to serve children with specified disorders; requires agency to seek federal waiver approval & implement approved waiver subject to availability of funds & certain limitations; authorizes rules. Amends 409.912. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

CS/SB 1354 (3R) by the Committee on Children and Families, Senator Fasano and others—

Sexual Offenders; prohibits sex offender from having contact with child younger than 18; provides exception; provides that Parole Commission or court may approve sex offender having supervised contact with child younger than 18 under specified conditions; directs DOH to prepare & maintain list of "qualified practitioners"; prohibits sex offender from accessing or using Internet or other computer services without approved safety plan, etc. Amends FS. Effective Date: 01/01/2006.

Read the second time and amended on April 29, 2005

HB 897 (3R) by Representative Hukill and others—

Trusts & Other Agency Relationships; includes additional investment instruments within definition of term "security account"; provides procedures for resignation of trustee; specifies circumstances in which court authorization is not required for trustee to exercise his or her power when conflict of interest exists; provides methods by which trustee may make certain changes to trusts, etc. Amends Ch. 738, 711.501, 737.309,.402,.403. Effective Date: 07/01/2005.

*Substituted for **CS/SB 1688 (SUB)** (Atwater) and read the second time on April 29, 2005*

CS/CS/SB 2232 (3R) by the Committees on Commerce and Consumer Services, Communications and Public Utilities and Senator Constantine—

Public Service Commission; creates Committee on Public Service Commission Oversight as standing joint committee of Legislature; requires that commission perform its duties independently; specifies that Governor has no planning or budgetary authority with respect to commission; specifies exclusive jurisdiction of PSC to regulate telecommunications companies; requires that broadband service remain free of state & local regulation, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 29, 2005

HB 307 (3R) by Representative Brown and others—

Physical Exam/Physician Assts./ARNP; authorizes physician assistants or advanced registered nurse practitioners to conduct physical examinations of Class "G" permit applicants; authorizes physician assistants or advanced registered nurse practitioners to conduct physical examinations of any person applying for employment as firefighter. Amends 493.6108, 633.34. Effective Date: 07/01/2005.

*Substituted for **SB 1042 (SUB)** (Crist) and read the second time on April 29, 2005*

CS/CS/CS/SB 1520 (3R) by the Committees on General Government Appropriations, Judiciary, Commerce and Consumer Services and Senator Lynn—

Consumer Protection; revises training requirements for obtaining Class "D" license; requires minimum number of hours of training in terrorism awareness or other training prescribed by DOACS; prohibits transmission of facsimile documents under certain circumstances; provides that chapter does not apply to amusement games or machines which operate by insertion of coin or other currency, etc. Amends FS. Effective Date: 10/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

CS/CS/SB 1090 (3R) by the Committees on Judiciary, Children and Families, Senator Campbell and others—

Minors/Psychotropic Medication; requires child's parent or legal guardian to provide certain information to CFS Dept.; specifies requirements for dept. re providing psychotropic medication to child in custody of dept.; defines term "psychotropic medication"; prohibits public school from denying student access to programs or services under certain conditions; authorizes refusal of psychological screening, etc. Amends Chs. 39, 394, 743.0645; creates 1006.0625. Effective Date: 07/01/2005.

Read the second time and amended on April 29, 2005

SB 2148 (3R) by Senator Argenziano—

Bingo; revises provisions for conduct of bingo sessions & games; restricts assistance in conduct of bingo to members; revises provisions for prizes & jackpots; provides for additional jackpot per session; prohibits free games; provides for accommodations for persons with physical disabilities; preempts regulation of bingo to state; prohibits certain persons from participating in certain bingo games, etc. Amends 849.0931, .161. Effective Date: 07/01/2005.

Read the second time and amended on April 29, 2005

CS/CS/SB 1968 (3R) by the Committees on Governmental Oversight and Productivity, Education and Senator Lawson—

Building Designations; designates Kleist Health Education Center & Herbert J. & Margaret S. Sugden Hall at Fla. Gulf Coast University; designates James E. "Jim" & Linda King, Jr. Student Union Bldg. at Univ. of N. Florida; designates Reubin O'D. Askew Student Life Center, Sherrill Williams Ragans Hall, John Thrasher Bldg., Mike Martin Field at Dick Houser Stadium, & JoAnne Graf Softball Field at F.S.U.; authorizes universities to erect markers, etc. Creates 15.052. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

CS/SB 2222 (3R) by the Committee on Government Efficiency Appropriations and Senator King—

Economic Development; increases cap on refunds from Economic Development Trust Fund; provides for separate accounting for refunds to certain industries; defines term "aerospace industry" & redefines term "target industry business" for purposes of tax refund program for such businesses; conforms cross-references. Amends 288.095, .106, .107, 290.00677. Effective Date: 07/01/2005.

Read the second time on April 29, 2005

HB 291 (3R) by Representatives Evers, Coley and others—

Condominiums/Administration Board; provides for effect of actions taken by members of board of administration of association designated by developer; requires examination & certification of certain defects by certain licensed individuals or entities. Amends 718.301. Effective Date: 07/01/2005.

Substituted for CS/SB 1492 (SUB) (Clary), read the second time and amended on April 29, 2005

CS/SB 546 (3R) by the Committee on Health and Human Services Appropriations and Senator Smith—

Lung Transplant Services/Medicaid; requires AHCA to reimburse lung transplant facilities a global fee for services provided to Medicaid recipients. Amends 409.9062. Effective Date: Upon becoming law.

Read the second time on April 29, 2005

CS/SB 60 (3R) by the Committee on Ways and Means, Senator Campbell and others—

FRS/Special Risk/Law Enforcement; provides membership in Special Risk Class for certain employees of law enforcement agency or medical examiner's office whose duties include collecting, examining, preserving, documenting, preparing, or analyzing physical evidence; provides declaration of important state interest. Amends 121.0515. Effective Date: 10/01/2005.

Read the second time on April 29, 2005

CS/HB 1725 (3R) by the Commerce Council, the Committee on Economic Development, Trade & Banking (CC), Representative Bilirakis and others—

Fla. Enterprise Zone Act; revises procedures for counties or municipalities to nominate area for designation as new enterprise zone; removes authority for certain counties to nominate more than one enterprise zone; specifies application of enterprise zone development plan requirements only to designations of new enterprise zones; establishes maximum number of enterprise zones allowed, subject to any new zones authorized by Legislature, etc. Amends FS. Effective Date: 07/01/2005.

Substituted for CS/CS/SB 1770 (SUB) (King) and read the second time on April 29, 2005

CS/SB 1024 (3R) by the Committee on Government Efficiency Appropriations and the Committee on Commerce and Consumer Services (King)—

Certified Capital Company Act/OGSR; (OPEN GOVERNMENT SUNSET REVIEW) removes October 2, 2005, repeal of information re active investigation or office review of certified capital company scheduled under OGSR Act; eliminates exemption from public-records requirements for social security numbers of any customers of certified capital company, complainants, or persons associated with said company or qualified business, etc. Amends 288.99. Effective Date: Upon becoming law.

Read the second time on April 29, 2005

*Identical to **HB 1817 (HC)** in the Committees on Commerce and Consumer Services, Banking and Insurance, Governmental Oversight and Productivity, Government Efficiency Appropriations, and Rules and Calendar*

CS/CS/SB 1766 (3R) by the Committees on Health Care, Education and Senator Crist—

School Students/Psychotropic Med; defines term "psychotropic medication"; prohibits public school from denying student access to programs or services under certain conditions; authorizes public school teachers & school district personnel to share certain information with student's parent; authorizes refusal of psychological screening, etc. Creates 1006.0625. Effective Date: Upon becoming law.

Read the second time on April 29, 2005

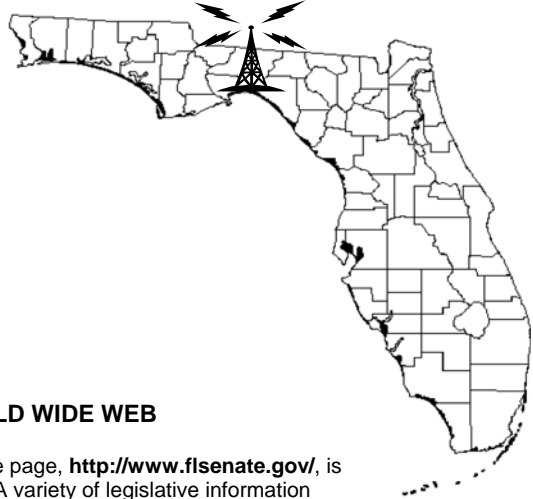
