Infrastructure Planning & Funding; revises requirements for capital improvements element of comprehensive plan; requires incorporation of selected water supply projects in comprehensive plan; authorizes planning for multijurisdictional water supply facilities; provides requirements for counties & municipalities re public school facilities element; provides for wiaver under certain circumstances; provides for expenditure of moneys in State Transportation Trust Fund, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on May 2, 2005

CS/CS/CS/SB 444 (3R) by the Committees on Ways and Means, Governmental Oversight and Productivity, Environmental Preservation, Senator Dockery and others—

Water Supplies; encourages cooperation in development of water supplies; encourages municipalities, counties, & special districts to create regional water supply authorities; requires water management districts to detail specific allocations to be used for alternative water supply development in their annual budget submission; establishes economic incentives for alternative water supply development, etc. Amends Chs. 163, 373, 403, 570.085. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on May 2, 2005

CS/CS/SB 1964 (3R) by the Committees on Criminal Justice, Judiciary, Senator Webster and others—

Wrongful Incarceration Act; creates "Wrongful Incarceration Compensation Act"; requires courts to determine whether certain persons are wrongfully incarcerated persons; authorizes petitions to court for determination of wrongful conviction; authorizes compensation for certain wrongfully incarcerated persons; provides exceptions & limitations; provides procedures to apply to Attorney General for compensation; provides rulemaking authority, etc. Creates 961.01-.05. Effective Date: 07/01/2005.

Read the second time and amended on May 2, 2005

HJR 1727 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—

Constitution Amendments/Initiative; constitutional amendment to provide that revision or amendment proposed by initiative must amend or repeal existing section of Constitution on same subject &matter; must address basic or fundamental right of citizen of this state; or must change basic structure of govt. as established in Articles II, III, IV, or V of Constitution, except that no revision or amendment may deprive branches of govt. of any existing powers, etc. Amends s. 3, Art. XI.

Substituted for **CS/SJR 4 (SUB)** (King), read the second time and amended on May 2, 2005

HJR 1723 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—

Initiatives/60 Percent of Electors; constitutional amendment to require that any proposed amendment to or revision of State Constitution, whether proposed by Legislature, by initiative, or by any other method, must be approved by at least 60 percent of voters of state voting on measure, rather than by simple majority, etc. Amends s. 5, Art. XI.

Substituted for **CS/SJR 6 (SUB)** (King) and read the second time on May 2, 2005

HJR 1741 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—

State Taxes or Fees; constitutional amendment to require approval by at least two-thirds of voters of state voting in election on any proposed amendment or revision to State Constitution imposing or authorizing imposition of any new tax or fee, increasing or authorizing increase in any existing tax or fee, or imposing significant fiscal impact on state, counties, school districts, municipalities, or special districts, etc. Amends s. 7, Art. XI.

Substituted for **CS/SJR 2200 (SUB)** (Atwater), read the second time and amended on May 2, 2005

HB 1471 (3R) by Representative Goodlette and others—

Petition Fraud/Voter Protection Act; provides for certain petitions to be verified by certain method; requires certain provisions to be satisfied before signature on petition may be counted; revises requirements for placement of constitutional amendments proposed by initiative on ballot for general election; provides for regulation of initiative petition circulators, etc. Amends Chs. 99, 100, 101, 104. Effective Date: 08/01/2005.

Substituted for **CS/CS/SB 1996 (SUB)** (Alexander), read the second time and amended on May 2, 2005

HCG 6001 (3R) by the Committee on Finance & Tax (FC), Representatives Greenstein, Benson and others—

Sales Tax/Hurricane Preparedness; (THIS BILL COMBINES H337 & 737) provides exemption from sales & use tax for sales of certain tangible personal property for certain period for certain purposes; authorizes DOR to adopt certain rules. Effective Date: Upon becoming law.

Substituted for CS/CS/SB's 1462 & 648 (SUB) (Baker & Campbell) and read the second time on May 2, 2005

HB 101 (3R) by Representative Sansom and others—

Books/Clothing/School Supplies/Tax; specifies period during which sale of books, clothing, & school supplies are exempt from tax on sales, use, & other transactions; provides definitions; provides exceptions; authorizes DOR to adopt rules. Effective Date: 07/01/2005.

Substituted for **CS/SB 476 (SUB)** (Webster) and read the second time on May 2, 2005

CS/CS/SB 2542 (3R) by the Committees on Justice Appropriations, Judiciary, Senator Smith and others—

State Judicial System; revises requirements for private court-appointed counsel; requires that circuit Article V indigent services committee establish compensation rates for court-appointed counsel or in cases of indigency; provides funding for teen court through assessment of additional court cost against each person who pleads guilty or nolo contendere to, or is convicted of, violation of criminal law, ordinance, or traffic offense in county, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on April 29, 2005

CS/SB 284 (3R) by the Committee on Judiciary, Senator Aronberg and others—

Consumer Protection; requires business persons maintaining computerized data that includes personal information to provide notice of breaches of system security under certain circumstances; revises criminal penalties re offense of fraudulently using, or possessing with intent to fraudulently use, personal identification information; provides minimum mandatory terms of imprisonment, etc. Creates 817.5681; amends 817.568. Effective Date: 07/01/2005.

Read the second time and amended on April 28, 2005

CS/CS/CS/CS/SB 442 (3R) by the Committees on Government Efficiency Appropriations, Banking and Insurance, Regulated Industries, Community Affairs, Senator Bennett and others—

Building Safety; requires that specified percentage of funds appropriated under Hurricane Loss Mitigation Program be used for education concerning Fla. Building Code & for operation of disaster contractors network; provides that Insurance Regulation Office make recommendations to insurance industry based on report re Hurricane Loss Mitigation Program by DCA; provides legislative intent re interpretation of said code, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

Read the second time and amended on May 2, 2005

CS/CS/SB 332 (3R) by the Committees on Ways and Means, Environmental Preservation and Senator Dockery—

Water Protection & Sustainability TF; creates Water Protection &Sustainability Trust Fund within Environmental Protection Dept.; provides for sources of funds & purposes; provides for annual carryforward of funds; provides for future legislative review & termination or re-creation of trust fund. Creates 403.891. Effective Date: Contingent.

Read the second time on May 2, 2005

CS/CS/SB 2232 (3R) by the Committees on Commerce and Consumer Services, Communications and Public Utilities and Senator Constantine—

Public Service Commission; creates Committee on Public Service Commission Oversight as standing joint committee of Legislature; requires that commission perform its duties independently; specifies that Governor has no planning or budgetary authority with respect to commission; specifies exclusive jurisdiction of PSC to regulate telecommunications companies; requires that broadband service remain free of state &local regulation, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 29, 2005

HB 1659 (3R) by Representative Kottkamp and others—

Termination of Minor's Pregnancy; provides that actual notice shall be given by physician who will perform termination of pregnancy procedure; specifies information required to be included in notices; provides circumstances in which prior notice is not required; provides that violation of notice requirements by physicians shall be considered medical malpractice; requires Supreme Court to ensure certain proceedings are conducted expeditiously & lawfully, etc. Amends 390.01115. Effective Date: 07/01/2005.

Substituted for **CS/SB 1908 (SUB)** (Dockery), read the second time, third time, and amended on April 27, 2005

CS/CS/SB 594 (3R) by the Committees on Health Care, Banking and Insurance and Senator Fasano—

Health Ins./Surgical First Assistant; provides for payments to physician assistant under contracts providing for paying for surgical first assisting benefits or services; includes certified surgical first assistants, as defined, within certain benefits or services payment provisions; limits application. Amends 627.419. Effective Date: 07/01/2005.

Read the second time on May 2, 2005

CS/SB 718 (3R) by the Committee on Transportation and Economic Development Appropriations and Senator Sebesta—

Transportation Department; authorizes dept. to adopt rules governing leasing of property for joint public-private development; grants local governments authority to issue permits allowing limited temporary use of state transportation right-of-way; establishes maximum limit on state-funded infrastructure bank loans to State Transportation TF; revises requirements for projects intended to mitigate adverse effects of transportation projects; etc. Amends Chs. 337, 339, 373. Effective Date: 07/01/2005.

Read the second time on April 20, 2005

HB 1527 (3R) by Representative Lopez-Cantera and others—

Disposition of Unclaimed Property; specifies communication by documented telephone contact to avoid presumption of certain property being unclaimed; decreases time period for presumption of stock, equity interest, & certain debt of business association being unclaimed; revises requirements & procedures for claims by beneficiaries of deceased owners of said property; revises requirements for powers of attorney to recover property, etc. Amends Ch. 717. Effective Date: Upon becoming law.

Substituted for **CS/CS/SB 2494 (SUB)** (Clary), read the second time and amended on May 2, 2005

CS/SB 1030 (3R) by the Committee on Judiciary and Senator Campbell—

Vehicles/Financial Responsibility; expands definition of "rental company" for purposes of exclusion from exemption from application of certain limits of liability provisions to include certain holders of motor vehicle title or equity interest in motor vehicle title under certain circumstances. Amends 324.021. Effective Date: 07/01/2005.

Read the second time and amended on May 2, 2005

Similar to **HB 551 (HC)** in the Committees on Transportation, Banking and Insurance, and Judiciary

CS/SB 1098 (3R) by the Committee on Governmental Oversight and Productivity, Senator Smith and others—

Child Abuse Cases/Guardian Ad Litem; creates exception to exemption from public-records requirements for all records held by DCFS concerning reports of child abandonment, abuse, or neglect; creates exemption from such requirements for information obtained by guardian ad litem in discharge of his or her official duty; creates exemption from such requirements for certain I.D. & location info. re current or former guardian ad litem or spouse & children, etc. Amends 39.202,.0132, 119.07. Effective Date: 10/01/2005.

Read the second time and amended on May 2, 2005

CS/SB 1180 (3R) by the Committee on Health Care and Senator Campbell—

Medical Regulatory Boards; revises membership requirements; provides for expiration of terms of current members, appointment of new members to staggered terms, & appointment & terms of successors; provides for externship; provides that practitioner licensed in Medical Practice law may use as defense that practitioner relied in good faith on representations made to practitioner by drug manufacturer & that practitioner had no intent to violate law, etc. Amends Ch. 458, 459.015. Effective Date: Upon becoming law.

Read the second time and amended on May 2, 2005

CS/CS/SB 1766 (3R) by the Committees on Health Care, Education and Senator Crist—

School Students/Psychotropic Med; defines term "psychotropic medication"; prohibits public school from denying student access to programs or services under certain conditions; authorizes public school teachers & school district personnel to share certain information with student's parent; authorizes refusal of psychological screening, etc. Creates 1006.0625. Effective Date: Upon becoming law.

Read the second time on April 29, 2005

CS/SB 1344 (3R) by the Committee on Transportation and Economic Development Appropriations, Senator Sebesta and others—

Motor Vehicles; provides that unauthorized use of traffic signal preemption device is moving violation; provides clearance specifications for railroad-highway grade crossing; deletes requirement that portion of certain fees collected by tax collector be deposited in Highway Safety Operating Trust Fund; provides 4 points to be assessed against person's driver's license for violation of certain provision, etc. Amends FS. Effective Date: 07/01/2005.

Read the second time and amended on April 28, 2005

Similar to **HB 1697 (HC)** in the Committees on Transportation, Criminal Justice, Governmental Oversight and Productivity, and Transportation and Economic Development Appropriations

CS/SB 2432 (3R) by the Committee on Regulated Industries and Senator Bullard—

Cardrooms/Games of Dominoes; revises definitions to include dominoes as authorized game & to allow games other than card games to be played in cardrooms; authorizes rulemaking re poker &dominoes by Pari-mutuel Wagering Div. of DBPR; provides for supervision of dominoes games at cardroom; limits wagering re authorized games; provides that chapter does not apply to amusement games or machines which operate by insertion of coin or other currency. Amends Ch. 849. Effective Date: 07/01/2005.

Read the second time and amended on May 2, 2005

CS/CS/SB 2498 (3R) by the Committees on Judiciary, Banking and Insurance and Senator Campbell—

Warranty Associations; provides exemption from penalty provisions for certain service warranties; provides actual damages & costs for violations for which such statutory penalties do not apply; provides retroactive applicability; redefines term "service warranty". Effective Date: Upon becoming law.

Read the second time on May 2, 2005

HB 69 (3R) by Representative Quinones and others—

Lt. John Mickel & Dallas Begg Act; creates Fire & Emergency Incident Information Reporting Program within State Fire Marshal Div.; creates Fire & Emergency Incident Information System Technical Advisory Panel within division; provides criminal penalties for initiating pyrotechnic display in certain structures under certain circumstances; provides exception from application to certain wildland or prescribed live-fire training exercises, etc. Amends Ch. 633, 932.7055. Effective Date: Upon becoming law.

Substituted for **CS/SB 108 (SUB)** (Constantine) and read the second time on May 2, 2005

HB 75 (3R) by Representative Mahon and others—

Title Insurance; revises definitions of title insurance & related & primary title services; revises requirements for title insurers to issue title insurance; revises requirements for title insurers to preserve & retain certain evidence of searches & examinations; requires Insurance Regulation Office to approve title insurance forms & rates for certain title insurance. Amends 624.608, 627.7711,.7845. Effective Date: Upon becoming law except as otherwise provided.

Substituted for **CS/SB 638 (SUB)** (Wise) and read the second time on May 2, 2005

HB 151 (3R) by Representative Sorensen and others—

Health Care Act/Access/Poverty Level; revises definition of low-income person to expand poverty level family income criterion. Amends 766.1115. Effective Date: 07/01/2005.

Substituted for **SB 1032 (SUB)** (Bennett) and read the second time on May 2, 2005

HB 189 (3R) by Representative McInvale and others—

Hospice Facilities; includes said facilities within purview of Fla. Building Code; deletes provisions requiring Elderly Affairs Dept. to adopt physical plant standards for said facilities; requires that construction standards for said facilities be in compliance with Fla. Building Code; requires AHCA to provide technical assistance to Fla. Building Commission to update said code for hospice facilities. Amends 553.73, 400.605; creates 400.6051. Effective Date: 07/01/2005.

Substituted for **SB 112 (SUB)** (Constantine) and read the second time on May 2, 2005

HB 319 (3R) by Representative Ryan and others—

Freedom to Worship Safely Act; provides for upgrading of degree of offense that involves use or threat of physical force or violence if offense is committed on property of religious institution while victim is on property for purpose of participating in or attending religious service; provides for severity ranking of offenses; provides for application of severity ranking chart of Criminal Punishment Code; provides applicability, etc. Creates 775.0861; amends 921.0022. Effective Date: 07/01/2005.

Substituted for **CS/SB 1096 (SUB)** (Smith) and read the second time on May 2, 2005

HB 71 (3R) by Representative Quinones and others—

Motor Vehicle Speed Competitions; defines term "conviction"; specifies that section applies to motor vehicles; revises penalties for violation of prohibitions against described motor vehicle speed competitions; provides for impoundment of vehicles used in violation of motor vehicle speed competition provisions; provides for application of Fla. Contraband Forfeiture Act. Amends 316.191. Effective Date: 10/01/2005.

Substituted for **CS/SB 1428 (SUB)** (Haridopolos) and read the second time on May 2, 2005

HB 509 (3R) by Representative Reagan and others—

Construction Services/Prompt Payment; cites act as "Local Government Prompt Payment Act"; revises provisions re timely payment for purchases of construction services; revises deadlines for payment; creates "Florida Prompt Payment Act"; provides exemption for contractors making late payment to subcontractors when contract is subject to "Prompt Payment Act", etc. Amends Chs. 218, 255, 287.0585, 95.11. Effective Date: 10/01/2005.

Substituted for **CS/CS/SB 632 (SUB)** (Bennett) and read the second time on May 2, 2005

HB 523 (3R) by Representative Flores and others—

Evidence/Deceased/Incompetent Person; repeals provision re testimony of interested persons re oral communication with deceased or mentally incompetent person; provides hearsay exception in specified actions or proceedings for statement made by declarant who is unavailable due to death, illness, or infirmity regarding same subject matter as statement made by declarant that was previously offered by adverse party & admitted. Repeals 90.602; amends 90.804. Effective Date: 07/01/2005.

Substituted for **CS/SB 988 (SUB)** (Campbell) and read the second time on May 2, 2005

HB 1417 (3R) by Representative Murzin and others—

Land Surveying & Mapping; revises requirements to be entitled to take licensure examination to practice in this state as surveyor & mapper; authorizes certain photogrammetrists to qualify for license by endorsement; revises liability of partnerships & other business entities rendering professional surveying & mapping services; provides definition of "photogrammetrist"; conforms provision to definition of photogrammetrist. Amends 472.013,.015,.021,.005,.007. Effective Date: 07/01/2005.

Substituted for **CS/SB 2050 (SUB)** (Aronberg) and read the second time on May 2, 2005

HB 567 (3R) by Representative Galvano and others—

Alternative Plan Review & Inspection; expands authorization to use private providers to provide building code inspection services; includes fee owner contractors within such authorization; provides for establishment of registration system for private providers & authorized representatives of private providers for licensure compliance purposes; revises ground for taking certain disciplinary actions, etc. Amends 553.791, 468.621. Effective Date: 10/01/2005.

Substituted for **CS/SB 1470 (SUB)** (Constantine) and read the second time on May 2, 2005

HB 989 (3R) by Representative Mayfield and others—

Public Marinas/Boat Ramps/DEP; directs DEP to adopt rules to authorize local governments to construct & maintain all facilities, including public marinas & boat ramps; exempts certain facilities from development-of-regional-impact review; provides for regulatory criteria & for use of submerged lands; revises permit exemption requirements for floating vessel platforms or floating boat lifts. Amends 373.118, 403.183. Effective Date: 07/01/2005.

Substituted for **SB 2288 (SUB)** (Bennett), read the second time and amended on May 2, 2005

HB 499 (3R) by Representative Antone and others—

Property Appraiser Assessments; requires property appraisers to physically inspect property every 5 years for certain purposes; revises definition. Amends 193.023,.501. Effective Date: Upon becoming law.

Substituted for **CS/SB 1270 (SUB)** (Saunders) and read the second time on May 2, 2005

HB 1089 (3R) by Representative Greenstein-

Independent Postsecondary Education; provides requirements of independent postsecondary educational institutions licensed by Independent Education Commission; specifies acts that constitute violations & provides penalties therefor; provides requirements for investigation of suspected violation of chapter or rules; requires commission to adopt rules re issuance of citation to institution & violations for which citation may be issued, etc. Amends Ch. 1005, 1010.83. Effective Date: 07/01/2005.

Substituted for **SB 1250 (SUB)** (Wise) and read the second time on May 2, 2005

HB 1091 (3R) by Representative Greenstein-

Independent Education/Pub. Rec.; creates exemption from public records requirements for investigatory records, including minutes & findings of exempt probable cause panel meeting re suspected violations of specified provisions or commission rules; creates exemption from public meetings requirements for certain portions of meetings of probable cause panel; provides for future review & repeal; provides statement of public necessity. Amends 1005.38. Effective Date: Contingent.

Substituted for **CS/CS/SB 1272 (SUB)** (Wise) and read the second time on May 2, 2005

HB 449 (3R) by Representative Ambler and others—

H. Lee Moffitt Center/Pub. Rec.; expands public records exemption for proprietary confidential business information owned or controlled by not-for-profit corporation operating H. Lee Moffitt Cancer Center & Research Institute & its subsidiaries re trade secrets; provides for future review & repeal; provides statement of public necessity, etc. Amends 1004.43. Effective Date: Upon becoming law.

Substituted for **CS/SB 1082 (SUB)** (Miller) and read the second time on May 2, 2005

CS/CS/SB 1110 (3R) by the Committees on Ways and Means, Government Efficiency Appropriations and Senator Atwater—


